Whereas, Lt. Mulya Ram Reang, Gr-D under HO & DDO Inspector of Schools Amarpur, Gomati, Tripura, expired on 04/01/2019, while in service. The case comes under the purview of the 'Scheme for Compassionate Appointment/ Benefit of Government employees of Tripura' vide Notification of the GA(P&T) Department No.F.1(1)-GA(P&T)/18, dated 02/03/2019.

And

Whereas, Lt. Mulya Ram Reang, Gr-D expired at the age 52 years 06 month and there is no earning member in the family as per the report of the SDM, Amarpur, Gomati, Tripura his wife Smt. Barnati Reang is entitle under **Support Category-1(one)** in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till her deceased husband would have attained 60 years of age.



Whereas, as per the service record the date of birth of Lt. Mulya Ram Reang, Gr-D is 05/07/1966 and as per the Notification of the GA(P&T) Department dated 02.03.2019, his wife Smt Barnati Reang is eligible to get a Special Pension for the period w.e.f 05/01/2019 to 04/07/2026.

And

Whereas, the last basic pay of Lt Mulya Ram Reang, Gr-D was Rs.30600/- and as per PPO No.141926824 dated 31-12-2019 the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E), Tripura @ Rs.15300/- P.M for the period w.e.f 05/01/2019 to 04/01/2029.

Now, therefore the provisional special pension has been sanctioned in favour of Smt. Barnati Reang W/O Late Mulya Ram Reang, Gr-D @ Rs (30600—15300)= Rs15300/- + Admissible DR w.e.f 05/01/2019 to 31/03/2021 & @ Rs (30600—15300)= Rs15300/- +Admissible DR + 3% DA w.e.f 01/04/2021 to 30/06/2022 & @ Rs (30600—15300)= Rs15300/- + Admissible DR + 8% DA w.e.f 01/07/2022 to 30/11/2022 @Rs(30600—15300)=Rs15300/-+Admissible DR+20% DA w.e.f 01/12/2022 to 04/07/2026 subject to finalization by the Account General (A&E) Tripura and the amount will be debit able under Head of Account 2071-Pension & Other benefits, 01-Civil, 105-Family Pension 02-Pension, 01-General Pension, 04-Pensionary Charges (2271-01-105-02-01-04).
