The case comes under the purview of the 'Scheme for Compassionate Appointment/ Benefit of Government employees of Tripura' vide Notification of the GA(P&T) Department No.F.1(1)-GA(P&T)/18, dated 02/03/2019.

**Whereas,** Lt Budhiram Debbarma Ex-KBT expired at the age of 57 years 09 month 16 days and there is no earning member in the family in the family as per the report of the SDM, Mohanpur West Tripura his wife Smt. Sachi Rani Debbarma is entitle under **Support Category-1(one)** in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till her deceased husband would have attained 60 years of age.



**Whereas,** as per the service record the date of birth of Lt. Budhiram Debbarma Ex-KBT is **12/04/1964** and as per the Notification of the GA(P&T) Department dated 02.03.2019, his wife Smt Sachi Rani Debbarma is eligible to get a Special Pension for the period w.e.f 29/01/2022 to 11/04/2024.

And

**Whereas,** the last basic pay of Lt Budhiram Debbarma Ex-KBT was Rs.49200/- and as per **PPO No.142238254** dated 08-07-2022 the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E), Tripura @ Rs.24600/- P.M for the period w.e.f 29/01/2022 to 11/04/2031.

**Now,** therefore the provisional special pension has been sanctioned in favour of Smt. Sachi Rani Debbarma W/O Late Budhiram Debbarma Ex-KBT @ Rs (49200-24600)=Rs24600/- +Admissible DR+ 8% DA w.e.f 29/01/2022 to 30/11/2022 & @ Rs (49200-24600)=Rs 24600/- +Admissible DR+ 20% DA w.e.f 01/12/2022 to 11/04/2024 subject to finalization by the Account General (A&E) Tripura and the amount will be debit able under Head of Account 2071-Pension & Other benefits, 01-Civil, 105-Family Pension 02-Pension, 01- General Pension, 04-Pensionary Charges (2271-01-105-02-01-04).
