Whereas, Lt Sudhir Debbarma.Ex- KBT of Joynagar S.B(Pry) School under HO & DDO Inspector of Schools Jirania, West, Tripura expired on **29/05/2020** while in service, the case comes under the purview of the 'Scheme for Compassionate Appointment/ Benefit of Government employees of Tripura' vide Notification of the GA(P&T) Department No.F.1(1)-GA(P&T)/18, dated 02/03/2019.

And

Whereas, Lt Sudhir Debbarma. Ex- KBT expired at the age of 56 years 03 month 24 days and there is no earning member in the family as per the report of the SDM, Jirania, West, Tripura his wife Smt Bina Debbarma is entitle under **Support Category-1** in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till her deceased husband would have attained 60 years of age.

Whereas, as per the service record the date of birth of Lt. Sudhir Debbarma.Ex- KBT is **05/02/1964** and as per the Notification of the GA(P&T) Department dated 02.03.2019, his wife Smt Bina Debbarma is eligible to get a Special Pension for the period w.e.f. 30/05/2020 to 04/02/2024.

And

Whereas, the last basic pay of Lt Sudhir Debbarma. Ex- KBT was Rs. 53700/- and as per PPO No.142131435 dated 28-01-2021 the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E), Tripura @ Rs.26850/- P.M for the period w.e.f. 30/05/2020 to 29/05/2030.

Now, therefore the provisional special pension has been sanctioned in favour of Smt Bina Debbarma, W/O Late Sudhir Debbarma. Ex- KBT @ Rs (53700-26850) = Rs 26850/- + Admissible DR + Admissible DA w.e.f 30/05/2020 to 04/02/2024 subject to finalization by the Account General (A&E) Tripura and the amount will be debit able under Head of Account 2071-Pension & Other benefits, 01-Civil, 105-Family Pension 02-Pension, 01- General Pension, 04-Pensionary Charges (2271-01-105-02-01-04).
