Whereas, the last basic pay of Lt Chandra Das Reang. Ex- KBT was Rs. 52200/- and as per PPO No.142344969 dated 11-12-2023 the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E), Tripura @ Rs.26100/- P.M for the period w.e.f. 28/08/2023 to 27/08/2033.

Now, therefore the provisional special pension has been sanctioned in favour of Smt Anju Reang, W/O Late Chandra Das Reang. Ex- KBT @ Rs (52200–26100) = Rs 26100/- + Admissible DR + 20% DA w.e.f 28/08/2023 to 31/12/2023 & Rs (52200-26100)= Rs 26100/- + Admissible DR + 25% DA w.e.f 01/01/2024 to 08/10/2032 subject to finalization by the Account General (A&E) Tripura and the amount will be debit able under Head of Account 2071-Pension & Other benefits, 01-Civil, 105-Family Pension 02-Pension, 01- General Pension,04-Pensionary Charges (2271-01-105-02-01-04).
