**Sub:** Sanctioning Provisional Special Pension in favour of Smt Bina Debbarma W/O Late Manindra Debbarma Ex-H/M High of Chandmari High School under HO & DDO Inspector Schools Sadar "A" West, Tripura.

Whereas, Lt Manindra Debbarma Ex-H/M High of Chandmari High School under HO & DDO Inspector of Schools Sadar "A" West, Tripura expired on 25/08/2023 while in service, the case comes under the purview of the 'Scheme for Compassionate Appointment/ Benefit of Government employees of Tripura' vide Notification of the GA(P&T) Department No.F.1(1)-GA(P&T)/18, dated 02/03/2019.

And

Whereas, Lt Manindra Debbarma Ex-H/M High expired at the age of 58 years 09 month 12 days and there is no earning member in the family as per the report of the SDM, Khowai, Tripura his wife Smt Bina Debbarma is entitle under **Support Category-1** in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till her deceased husband would have attained 60 years of age.


And

Whereas, as per the service record the date of birth of Lt. Manindra Debbarma Ex-H/M High is 13/11/1964 and as per the Notification of the GA(P&T) Department dated 02.03.2019, his wife Smt Bina Debbarma is eligible to get a Special Pension for the period w.e.f. 26/08/2023 to 12/11/2024.

And

Whereas, the last basic pay of Lt Manindra Debbarma Ex-H/M High was Rs.83600/- and as per PPO No.142446697 dated 17-04-2024 the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E), Tripura @ Rs.41800/- P.M for the period w.e.f.26/08/2023 to 12/11/2031.

Now, therefore the provisional special pension has been sanctioned in favour of Smt Bina Debbarma, W/O Late Manindra Debbarma. Ex-H/M High @ Rs (83600-41800) = Rs 41800/- + Admissible DR+ 20% DA w.e.f 26/08/2023 to 31/12/2023 & Rs (83600-41800) = Rs 41800/- + Admissible DR+ 25% DA w.e.f. 01/01/2024 to 12/11/2024. subject to finalization by the Account General (A&E) Tripura and the amount will be debit able under Head of Account 2071-Pension & Other benefits, 01-Civil, 105-Family Pension 02-Pension, 01- General Pension, 04-Pensionary Charges (2271-01-105-02-01-04).
