NOTIFICATION

Sub: - Launching of Samagra Shiksha Abhiyan - an Integrated Scheme for School Education

The Ministry of Human Resource Development, Department of School Education & Literacy, Government of India has decided to introduce and implement **Samagra Shiksha Abhiyan- an Integrated Scheme for School Education (ISSE)** extending from Pre-School to Class-XII from the financial year 2018-19 by subsuming the existing 3(three) Centrally Sponsored Schemes of Sarva Shiksha Abhiyan (SSA), Rashtriya Madhyamik Shiksha Abhiyan (RMSA) and Teacher Education (TE). The decision has been communicated by the Joint Secretary of MHRD vide D.O. letter No.11-2/2017-EE.2013 dated 3rd April, 2018 and the Director of MHRD vide D.O. letter No.2-16/2017-EE.3 dated 5th April,2018.

The salient features and objectives of the scheme are as follows:-

- i. Provision of quality education and enhancing learning outcomes of students.
- ii. Bridging Social and Gender Gaps in School Education.
- iii. Ensuring equity and inclusion at all levels of school education.
- iv. Ensuring minimum standards in schooling provisions.
- v. Promoting vocationalization of education.
- vi. Support States in implementation of Right of Children to Free and Compulsory Education (RTE) Act, 2009.
- vii. Strengthening and up-gradation of SCERTs / State Institutes of Education and DIETs as nodal agencies for teacher training tenure.

In accordance with the decision of the Government of India, it has now been decided to launch and implement the Integrated Scheme for School Education in the State under a single State Implementing Society of Samagra Shiksha Abhiyan, Tripura and under single administrative control of a State Project Director by subsuming /merging of the existing Centrally Sponsored Schemes of Sarva Shiksha Abhiyan (SSA), Rashtriya Madhyamik Shiksha Abhiyan (RMSA) and Teacher Education (TE).

The Samagra Shiksha Abhiyan shall be implemented in the State for overall development of School Education from Pre-School to Class-XII primarily for a period of 2 years from **1st April, 2018 to 31st March, 2020** with the existing teaching staff, non-teaching managerial & technical manpower, resource persons and all resources already created under SSA, RMSA and Teacher Education Programmes at State, District, Block, Cluster, Village and School levels.

Various assets created, liabilities born and manpower engaged under SSA, RMSA and Teacher Education Programmes at different levels shall be transferred to the State Implementing Society of Samagra Shiksha Abhiyan, Tripura.

All District Education Officers, Inspectors of Schools (State), Inspectors of Schools (TTAADC), BRC/URC and CRC Coordinators shall accordingly take appropriate action at the respective level for implementation of Samagra Shiksha Abhiyan.
