Whereas Lt. Goutam Das Gupta.Ex-A/T of Sukanta Colony SB School under HO & DDO Inspector of Schools, Jirania, Tripura West. expired on 14/01/2022. while in service, the case comes under the purview of the 'Scheme for Compassionate Appointment/ Benefit of Government employees of Tripura' vide Notification of the GA(P&T) Department No.F.1(1)-GA(P&T)/18, dated 02/03/2019.

Whereas Lt Goutam Das Gupta.Ex-A/T expired at the age of 51 years 11 month 17 days and there is no earning member in the family as per the report of the SDM, Jirania, West Tripura his wife Smt Mitra Deb Das Gupta. comes under **Support Category-1** in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till her deceased husband would have attained 60 years of age.



Whereas as per the service record the date of birth of Lt. Goutam Das Gupta.Ex-A/T is 27/01/1970 and as per the Notification of the GA(P&T) Department dated 02.03.2019, his wife Smt Mitra Deb Das Gupta is eligible to get a Special Pension for the period w.e.f. 15/01/2022 to 26/01/2030.

And

Whereas the last basic pay of Lt Goutam Das Gupta.Ex-A/T was Rs. 52200/- and as per **PPO No.142238659** dated 08-08-2022 the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E), Tripura @ Rs.26100/- P.M for the period w.e.f. 23/01/2023 to 25/10/2030.

Now therefore the provisional special pension has been sanctioned in favour of Smt Mitra Deb Das Gupta W/O Lt Goutam Das Gupta. Ex-A/T @ Rs (52200-26100)=Rs 26100/- +Admissible DR +3% DA w.e.f 15/01/2022 to 30/06/2022 & @ Rs (52200-26100)=Rs 26100/- +Admissible DR+8% DA.w.e.f 01/07/2022 to 30/11/2022 & @ Rs(52200-26100)=Rs 26100/- +Admissible DR+20% DA.w.e.f 01/12/2022 to 26/01/2030.subject to finalization by the Account General (A&E) Tripura and the amount will be debit able under Head of Account 2071-Pension & Other benefits, 01-Civil, 105-Family Pension 02-Pension, 01- General Pension, 04-Pensionary Charges (2271-01-105-02-01-04).
