Taprai Sadhan Jamatia.Ex-KBT of Tairupa Bari H/S (Pry) School under HO & DDO Inspector of Schools Killa Udaipur, Gomati, Tripura. expired on **23/03/2023**. while in service, the case comes under the purview of the 'Scheme for Compassionate Appointment/ Benefit of Government employees of Tripura' vide Notification of the GA(P&T) Department No.F.1(1)-GA(P&T)/18, dated 02/03/2019.

**Whereas,** Lt Taprai Sadhan Jamatia.Ex-KBT expired at the age of 54 years 02 month 18 days and there is no earning member in the family as per the report of the SDM Udaipur, Gomati, Tripura his wife Smt Mukta Kumari Jamatia.is entitle under **Support Category-1** in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till her deceased husband would have attained 60 years of age.

And

**Whereas,** as per the service record the date of birth of Lt. Taprai Sadhan Jamatia.Ex-KBT is **05/01/1969** and as per the Notification of the GA(P&T) Department dated 02.03.2019, his wife Smt Mukta Kumari Jamatia is eligible to get a Special Pension for the period w.e.f. 24/03/2023 to 04/01/2029.

And

**Whereas,** the last basic pay of Lt Taprai Sadhan Jamatia.Ex-KBT was Rs. 52200/- and as per PPO No.142343706 dated 07-08-2023 the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E), Tripura @ Rs.26100/- P.M for the period w.e.f. 24/03/2023 to 23/03/2033.

**Now,** therefore the provisional special pension has been sanctioned in favour of Smt Mukta Kumari Jamatia, W/O Late Taprai Sadhan Jamatia.Ex-KBT @ Rs(52200-26100)=Rs26100/- + Admissible DR+20% DA w.e.f 24/03/2023 to 31/12/2023 & Rs (52200-26100)=Rs 26100/- + Admissible DR + 25% DA w.e.f 01/01/2024 to 04/01/2029. subject to finalization by the Account General (A&E) Tripura and the amount will be debit able under Head of Account 2071-Pension & Other benefits, 01-Civil, 105-Family Pension 02-Pension, 01- General Pension, 04-Pensionary Charges (2271-01-105-02-01-04).
