Sub: Sanctioning Provisional Special Pension in favour of Sri Narayan Deb Chowdhury H/O Late Kakali Nandi. Ex- LDC of Inspectorate of Schools Panisagar, North Tripura under HO & DDO Inspector of Schools Panisagar, North Tripura.

Whereas, Lt. Kakali Nandi. Ex-LDC of Inspectorate of Schools Panisagar, North Tripura, under HO & DDO Inspector of Schools Panisagar, North Tripura expired on 29/10/2022. While in service, the case comes under the purview of the 'Scheme for Compassionate Appointment/ Benefit of Government employees of Tripura' vide Notification of the GA(P&T) Department No.F.1(1)-GA(P&T)/18, dated 02/03/2019.

And

Whereas, Lt. Kakali Nandi. Ex-LDC expired at the age of 52 years 03 month 28 days and there is no earning member in the family as per the report of the SDM, Dharmanagar, North Tripura, her husband Sri Narayan Deb Chowdhury is entitled under **Support Category-1** in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till his deceased wife would have attained 60 years of age.

And

Whereas, as per the service record the date of birth of Lt. Kakali Nandi. Ex-LDC is 01/02/1970 and as per the Notification of the GA(P&T) Department dated 02.03.2019, her husband Sri Narayan Deb Chowdhury is eligible to get a Special Pension for the period w.e.f. 30/05/2022 to 31/01/2030.

And

Whereas, the last basic pay of Lt. Kakali Nandi. Ex-LDC was Rs.27900/- and as per PPO No.142239159 dated 09-09-2022 the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E), Tripura @ Rs.13950/- P.M for the period w.e.f. 30/05/2022 to 29/05/2032.

Now, therefore the provisional special pension has been sanctioned in favour of Sri Narayan Deb Chowdhury, H/O Late Kakali Nandi. Ex-LDC @ Rs(27900-13950)=Rs 13950/- +Admissible DR+ 3% DA w.e.f 30/05/2022 to 30/06/2022 & Rs(27900-13950)=Rs13950/-+Admissible DR+ 8% DA w.e.f 01/07/2022 to 30/11/2022 & Rs(27900-13950)=Rs13950/-+Admissible DR+ 20% DA w.e.f.01/12/2022 to 31/12/2023 & Rs(27900-13950)=Rs13950/- +Admissible DR+ 25% DA w.e.f.01/01/2024 to 31/01/2030 subject to finalization by the Account General (A&E) Tripura and the amount will be debit able under Head of Account 2071-Pension & Other benefits, 01-Civil, 105-Family Pension 02-Pension, 01- General Pension, 04-Pensionary Charges (2271-01-105-02-01-04).
