Whereas, Lt Juthika Rani Chanda. Ex- H/M(SB) expired at the age of 59 years 08 month 14 days and there is no earning member in the family as per the report of the SDM, Dharmanagar North Tripura her son Sri Pranjal Pal is entitle under **Support Category-1(one)** in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till her deceased mother would have attained 60 years of age.



Whereas, as per the service record the date of birth of Lt. Juthika Rani Chanda. Ex- H/M(SB) is 09/01/1962 and as per the Notification of the GA(P&T) Department dated 02.03.2019, her son Sri Pranjal Pal is eligible to get a Special Pension for the period w.e.f 23/09/2021 to 08/01/2022.

And

Whereas, the last basic pay of Lt Juthika Rani Chanda Ex- H/M(SB) was Rs.89700/- and as per PPO No.142236429 dated 24-03-2022 the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E), Tripura @ Rs.44850/- P.M for the period w.e.f 23/09/2021 to 26/07/2022.

Now, therefore the provisional special pension has been sanctioned in favour of Sri. Pranjal Pal S/O Late Juthika Rani Chanda Ex- H/M(SB) @ Rs (89700-44850)=Rs 44850/- +Admissible DR+ 3% DA w.e.f 23/09/2021 to 08/01/2022 subject to finalization by the Account General (A&E) Tripura and the amount will be debit able under Head of Account 2071-Pension & Other benefits, 01-Civil, 105-Family Pension 02-Pension, 01- General Pension, 04-Pensionary Charges (2271-01-105-02-01-04).
