Whereas, Lt Chandan De Ex- UGT of Kamini Das Para JB School under HO & DDO Inspector of Schools Santirbazar, Tripura (S) expired on **26/03/2021**. while in service. The case comes under the purview of the 'Scheme for Compassionate Appointment/ Benefit of Government employees of Tripura' vide Notification of the GA(P&T) Department No.F.1(1)-GA(P&T)/18, dated 02/03/2019.

And

Whereas, Lt Chandan De Ex-UGT expired at the age of 54 years 02 month 21 days and there is no earning member in the family as per the report of the SDM, Santirbazar, Tripura (S) his wife Smt. Rama Sarkar (De) is entitle under **Support Category-1(one)** in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till her deceased husband would have attained 60 years of age.



Whereas, as per the service record the date of birth of Lt. Chandan De Ex-UGT is **05/01/1967** and as per the Notification of the GA(P&T) Department dated **02.03.2019** his wife Smt Rama Sarkar De is eligible to get a Special Pension for the period w.e.f **27/03/2021 to 04/01/2027**.

And

Whereas, the last basic pay of Lt Chandan De Ex-UGT was Rs.52200/- and as per PPO No.142135294 dated 30-12-2021 the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E), Tripura @ Rs.25350/- P.M for the period w.e.f 27/03/2021 to 26/03/2031.

Now, therefore the provisional special pension has been sanctioned in favour of Smt. Rama Sarkar De W/O Late Chandan De Ex-UGT @ Rs (50700-25350)=Rs 25350/- + Admissible DR+ 3% DA w.e.f 27/03/2021 to 30/06/2022 & @ Rs(50700-25350)=Rs 25350/- + Admissible DR+ 8% DA w.e.f 01/07/2022 to 30/11/2022 & @ Rs (50700-25350)=Rs 25350/- + Admissible DR+ 20% DA w.e.f 01/12/22 to 04/01/2027 subject to finalization by the Account General (A&E) Tripura and the amount will be debit able under Head of Account 2071-Pension & Other benefits, 01-Civil, 105-Family Pension 02-Pension, 01- General Pension, 04-Pensionary Charges (2271-01-105-02-01-04).
