**Sub:** Sanctioning Provisional Special Pension in favour of Smt Ranjan Mala Tripura, W/O Late Asha Dhan Tripura, Ex-H/M (Pry) of South Hitchachara High (Pry) School under HO & DDO Inspector of Schools, Sabroom, South, Tripura.

**Whereas,** Late Asha Dhan Tripura, Ex-H/M (Pry) of South Hitchachara High (Pry) School under HO & DDO Inspector of Schools, Sabroom, South, Tripura expired on **13/10/2023** while in service, the case comes under the purview of the 'Scheme for Compassionate Appointment/ Benefit of Government employees of Tripura' vide Notification of the GA(P&T) Department No.F.1(1)-GA(P&T)/18, dated 02/03/2019.

**And**

**Whereas,** Late Asha Dhan Tripura, Ex-H/M (Pry) expired at the age of 55 years and 12 days and there was no earning member in the family at the time of death on **13/10/2023** as per the report of the SDM Sabroom, South, Tripura. His wife Smt Ranjan Mala Tripura is entitled under **Support Category-1** in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till her deceased husband would have attained 60 years of age.

**And**

**Whereas,** as per the service record the date of birth of Late Asha Dhan Tripura, Ex-H/M (Pry) is **01/10/1968** and as per the Notification of the GA(P&T) Department dated 02.03.2019. His wife Smt Ranjan Mala Tripura is eligible to get a Special Pension for the period w.e.f 14/10/2023 to 30/09/2028.

**And**

**Whereas,** the last basic pay of Late Asha Dhan Tripura, Ex-H/M (Pry) was Rs.49200/- and as per **PPO No.142445984 dated 29/02/2024** the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E) Tripura at the rate of Rs.24600/- per month for the period w.e.f 14/10/2023 to 13/10/2033.

Now, therefore the provisional special pension has been sanctioned in favour of Smt Ranjan Mala Tripura, W/O Late Asha Dhan Tripura, Ex-H/M (Pry) at the rate of Rs(49200-24600)=Rs.24600/- + Admissible DR 20% w.e.f 14/10/2023 to 31/12/2023 & Rs(49200-24600)=Rs.24600/- + Admissible DR 25% w.e.f 01/01/24 to 31/10/2024 & Rs (49200-24600)=Rs.24600/- + Admissible DR 30% DA.w.e.f 01/11/2024. subject to finalization by the Accountant General (A&E) Tripura and the amount will be debitible under Head of Account 2071-Pension & Other benefits, 01-Civil, 105-Family Pension 02-Pension, 01- General Pension, 04-Pensionary Charges (2271-01-105-02-01-04).
