Whereas, the last basic pay of Late Gopendra, Debnath, Ex-UGT was Rs.50700/- and as per PPO No.142550645 dated 13/03/2025 the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E)Tripura @ Rs.25350/-P.M for the period w.e.f 02/05/2024 to 01/05/2034.

Now, therefore, the provisional Special Pension is hereby sanction in favour of Smt Saraswati Debnath, W/O Late. Gopendra, Debnath, Ex-UGT Rs(50700-25350)=Rs.25350/ + Admissible DR 20% w.e.f 02/05/2024 to 30/06/2024,Rs(50700-25350)=Rs.25350/+Admissible DR 25% w.e.f 01/07/2024 to 31/10/2024,Rs(50700-25350)=Rs.25350/+Admissible DR 30% w.e.f 01/11/2024 to 31/03/2025 & Rs (50700-25350)=Rs.25350 /+ Admissible DR 33% w.e.f 01/04/2025 to time to time increase up to 01/01/2028. Subject to finalization by the Account General (A&E) Tripura and the amount will be debatable under Head of Account 2071-Pension & Other benefits,01-Civil,105-Family Pension 02-Pension, 01- General Pension, 04-Pensionary Charges (2271-01-105-02-01-04).
