Sub: Sanctioning Provisional Special Pension in favour of Smt Biswa Kumari Debbarma, W/O Late Swapan Debbarma, Ex-, UGT of Sonaicherri J.B School under HO & DDO Inspector of Schools Kadamtala, North, Tripura.

Whereas, Late Swapan Debbarma, Ex-, UGT of Sonaicherri J.B School under HO & DDO Inspector of Schools Kadamtala, North Tripura expired on **05/10/2023** while in service, the case comes under the purview of the 'Scheme for Compassionate Appointment/ Benefit of Government employees of Tripura' vide Notification of the GA(P&T) Department No.F.1(1)-GA(P&T)/18, dated 02/03/2019.

And

Whereas, Late Swapan Debbarma, Ex-, UGT expired at the age of 53 years 11 month 17 days and there was no earning member in the family at the time of death on **05/10/2023** as per the report of the SDM Teliamura, Khowai, Tripura. His wife Smt Biswa Kumari Debbarma is entitled under **Support Category-1** in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till her deceased husband would have attained 60 years of age.

And

Whereas, as per the service record the date of birth of Late Swapan Debbarma, Ex-, UGT is **18/10/1969** and as per the Notification of the GA(P&T) Department dated 02.03.2019 his wife Smt Biswa Kumari Debbarma is eligible to get a Special Pension for the period w.e.f 06/10/2023 to 17/10/2029.

And

Whereas, the last basic pay of Late Swapan Debbarma, Ex-, UGT was Rs.49200/- and as per **PPO No.142447585 dated 20/06/2024** the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E) Tripura @ Rs.24600/- P.M for the period w.e.f 06/10/2023 to 05/10/2033.

Now, therefore the provisional special pension has been sanctioned in favour of Biswa Kumari Debbarma, W/O Late Swapan Debbarma, Ex-, UGT of Rs (49200-24600)= Rs.24600/- + Admissible DR 20% w.e.f 06/10/2023 to 30/06/2024 & Rs (49200-24600)= Rs.24600/- + Admissible DR 25% w.e.f 01/07/2024 to 30/10/2024 & Rs (49200-24600) = Rs.24600/- + Admissible DR 30% w.e.f 01/11/2024 to time to time increase up to 17/10/2029 subject to the finalization by the Accountant General (A&E) Tripura and the amount will be debitabe under Head of Account 2071- Pension & Other benefits, 01-Civil, 105-Family Pension 02-Pension, 01- General Pension, 04-Pensionary Charges (2271-01-105-02-01-04).
