Sub: Sanctioning Provisional Special Pension in favour of Smt Supriya Chakma W/O Late Sunil Chakma, Ex-UGT of Kamdevcherra High (Pry) School under HO & DDO Inspector of Schools Pecharthal, Unakoti, Tripura.

Whereas, Late Sunil Chakma, Ex- UGT of Kamdevcherra High (Pry) School under HO & DDO Inspector of Schools, Pecharthal, Unakoti, Tripura expired on **06/03/2024** while in service, the case falls under the purview of the 'Scheme for Compassionate Appointment/ Benefit to Government employees of Tripura 'vide Notification of the GA(P&T) Department No.F.1(1)-GA(P&T)/18, dated 02/03/2019.

And

Whereas, Late Sunil Chakma, Ex- UGT expired at the age of 54 years 07 months and 01 day and there was no earning member in the family at the time of death on **06/03/2024** as per the report of the SDM, Kumarghat, Unakoti Tripura. His wife Smt Supriya Chakma is entitled under **Support Category-1** in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefits until her deceased husband would have attained the age of 60 years.

And

Whereas, as per the service record the date of birth of Late Sunil Chakma, Ex-,UGT is **05/08/1969** and as per the Notification of the GA(P&T) Department dated 02.03.2019 his wife Smt Supriya Chakma is eligible to get a Special Pension for the period w.e.f 07/03/2024 to 04/08/2029.

And

Whereas, the last basic pay of Late Sunil Chakma, Ex-UGT was Rs.47800/- and as per **PPO No.142448435 dated 30/08/2024** the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E) Tripura @ Rs.23900/- P.M for the period w.e.f 07/03/2024 to 06/03/2034.

Now, therefore, the provisional Special Pension is hereby sanctioned in favour of Smt Supriya Chakma, W/O Late Sunil Chakma, Ex-UGT for Rs (47800-23900)=Rs.23900/+ Admissible DR 20% w.e.f 07/03/2024 to 30/06/2024, Rs(47800-23900)= Rs 23900/+ Admissible DR 25% w.e.f 01/07/2024 to 31/10/2024, Rs (47800-23900)= Rs 23900/+ Admissible DR 30% w.e.f 01/11/2024 to 31/03/2025 & Rs(47800-23900)=Rs 23900/+Admissible DR 33% w.e.f 01/04/2025 to time to time increase Admissible DR up to 04/08/2029 subject to finalization by the Accountant General (A&E) Tripura and the amount will be debitabe under Head of Account 2071-Pension & Other benefits, 01-Civil, 105-Family Pension 02-Pension, 01- General Pension, 04-Pensionary Charges (2271-01-105-02-01-04).
