Sub: Sanction of Provisional Special Pension in favour of Smt. Satyabama Murasing, W/O Late Gour Hari Murasing, Ex-KBT of Neoramura J.B. School under HOO & DDO Inspector of Schools, Sonamura, Sepahijala, Tripura.

Whereas, Late Gour Hari Murasing, Ex-KBT of Neoramura J.B. School under HOO & DDO Inspector of Schools, Sonamura, Sepahijala, Tripura, expired on 20/06/2019 while in service, and the case falls under the purview of the "Scheme for Compassionate Appointment/Benefit to Government Employees of Tripura" as per GA(P&T) Department Notification No.F.1(1)-GA(P&T)/18 dated 02/03/2019.

And

Whereas, Late Gour Hari Murasing, Ex-KBT, expired at the age of 57 years, 8 months, and 16 days, and there was no earning member in the family at the time of his death on 20/06/2019, as per the report of the SDM, Sonamura, Sepahijala, Tripura. His wife, Smt. Satyabama Murasing, is entitled under Support Category-1 in accordance with the GA(P&T) Department Notification No.F.1(1)-GA(P&T)/18 dated 02/03/2019 and is eligible to receive Special Pension benefits until her deceased husband would have attained the age of 60 years.

And

Whereas, as per service records, the date of birth of Late Gour Hari Murasing, Ex-KBT, is 04/10/1961 and as per the aforementioned notification, his wife Smt. Satyabama Murasing is eligible to receive Special Pension for the period from 21/06/2019 to 03/10/2021.

And

Whereas, the last basic pay of Late Gour Hari Murasing, Ex-KBT, was ₹68,400/-, and as per PPO No. 142026963 dated 14/01/2020, the Enhanced Family Pension (EFP) has been sanctioned by the Accountant General (A&E), Tripura @ ₹34,200/- per month for the period from 21/06/2019 to 03/10/2028.

Now, therefore, the Provisional Special Pension is hereby sanctioned in favour of Smt. Satyabama Murasing, W/O Late Gour Hari Murasing, Ex-KBT, @ ₹(68,400 - 34,200) = ₹34,200/- per month w.e.f. 21/06/2019 to 28/02/2021, and @ ₹34,200/- plus admissible Dearness Relief @ 3% w.e.f. 01/03/2021 to 03/10/2021, subject to finalization by the Accountant General (A&E), Tripura. The amount shall be debitale under Head of Account: 2071 - Pension & Other Retirement Benefits, 01 - Civil, 105 - Family Pension, 02 - Pension, 01 - General Pension, 04 - Pensionary Charges (2071-01-105-02-01-04).
