**Sub:** Sanctioning for Provisional Special Pension in favour of Smt. Debaki Reang, W/O Late Bidya Joy Reang, Ex-KBT of Tirtharam Chow Para S.B School under HO & DDO Inspector of Schools, Karbook, Gomati, Tripura.

**Whereas,** Late Bidya Joy Reang, Ex-KBT of Tirtharam Chow Para S.B School under HO & DDO Inspector of Schools, Karbook, Gomati, Tripura expired on 20/10/2023 while in service, the case comes under the purview of the 'Scheme for Compassionate Appointment/ Benefit of Government employees of Tripura vide Notification of the GA(P&T) Department No.F.1(1)-GA(P&T)/18, dated 02/03/2019.

**And**

**Whereas,** Late Bidya Joy Reang, Ex-KBT expired at the age of 52 years 07 months 24 days and there is no earning member in the family at the time of death on 20/10/2023 as per the report of the SDM Karbook, Gomati, Tripura. His wife Smt Debaki Reang is entitled under Support Category-1 in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till her deceased husband would have attained 60 years of age.

**Whereas,** as per the service record the date of birth of Late Bidya Joy Reang, Ex-KBT is 26/02/1971 and as per the Notification of the GA(P&T) Department dated 02.03.2019 his wife Smt Debaki Reang is eligible to get a Special Pension for the period w.e.f 21/10/2023 to 25/02/2031.

**And**

**Whereas,** the last basic pay of Late Bidya Joy Reang, Ex-KBT was Rs.60800/- and as per PPO No.142446977 dated 09/05/2024 the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E) Tripura @ Rs.30400/-P.M for the period w.e.f 21/10/2023 to 20/10/2033.

Now, therefore the provisional special pension has been sanctioned in favour of Smt Debaki Reang, W/O Late Bidya Joy Reang, Ex-KBT at the rate of Rs (60800-30400)= Rs.30400/- + Admissible DR 20% w.e.f 21/10/2023 to 31/12/2024 & Rs(60800-30400)= Rs.30400/- + Admissible DR+25.w.e.f 01/01/24 to 31/10/2024 & Rs (60800-30400)= Rs.30400/- + Admissible DR 30%.w.e.f 01/11/2024 subject to finalization by the Accountant General (A&E) Tripura and the amount will be debitale under Head of Account 2071-Pension & Other benefits, 01-Civil, 105-Family Pension 02-Pension, 01- General Pension, 04-Pensionary Charges (2271-01-105-02-01-04).
