Whereas, Lt Satya Bhushan Chowdhury.Ex-A/T (Pry) expired at the age of 57 years 08 days and there is no earning member in the family as per the report of the SDM Gonda Twisa, Dhalait Tripura his wife Smt Sabita Bhowmik.comes under **Support Category-1** in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till her deceased husband would have attained 60 years of age.



Whereas, as per the service record the date of birth of Lt. Satya Bhushan Chowdhury.Ex-A/T (Pry) is 09/11/1964 and as per the Notification of the GA(P&T) Department dated 02.03.2019, his wife Smt Sabita Bhowmik is eligible to get a Special Pension for the period w.e.f. 17/11/2021 to 08/11/2024.

Whereas, the last basic pay of Lt Satya Bhushan Chowdhury.Ex-A/T (Pry) was Rs.52200/- and as per **PPO No.142340833** dated 03-02-2023 the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E),Tripura @ Rs.26100/- P.M for the period w.e.f. 17/11/2021 to 08/11/2031.

Now, therefore the provisional special pension has been sanctioned in favour of Smt Sabita Bhowmik W/O Lt Satya Bhushan Chowdhury.Ex-A/T (Pry) @ Rs (52200-26100)=Rs 26100/- +Admissible DR +3% DA w.e.f 17/11/2021 to 30/06/2022 & @ Rs (52200-26100)=Rs 26100/- +Admissible DR +8% DA w.e.f 01/07/2022 to 30/11/2022 & @ Rs (52200-26100)=Rs 26100/- +Admissible DR +20% DA w.e.f 01/12/2022 to 08/11/2024.subject to finalization by the Account General (A&E) Tripura and the amount will be debit able under Head of Account 2071-Pension & Other benefits, 01-Civil, 105-Family Pension 02-Pension, 01- General Pension,04-Pensionary Charges (2271-01-105-02-01-04).
