**Sub:-** Sanctioning Provisional Special Pension in favour of Smt.Kuchi Rung Reang, W/O.Late. Sulayham Reang, Ex-Group-D under HO & DDO, Inspector of Schools(State) Chailengta, LTV. Dhalai Tripura.

**Whereas,** Late. Sulayham Reang, Ex-Group-D under HO & DDO, Inspector of Schools (State) Chailengta, LTV. Dhalai Tripura expired on **02/04/2022** while in service, the case comes under the purview of the 'Scheme for Compassionate Appointment/ Benefit of Government employees of Tripura vide Notification of the GA(P&T) Department No.F.1(1)-GA(P&T)/18, dated 02/03/2019.

**Whereas,** Late. Sulayham Reang, Ex-Group-D expired at the age of 56 years 01 month and there is no earning member in the family as per the report of the SDM, Longtharai Valley, Chailengta Dhalai Tripura. His wife Smt.Kuchi Rung Reang, is entitled under **Support Category-1** in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till her deceased husband would have attained 60 years of age.

**Whereas,** as per the service record the date of birth of Late. Sulayham Reang, Ex-Group-D, is 02/03/1966 and as per the Notification of the GA(P&T) Department dated 02.03.2019 his wife Smt. Kuchi Rung Reang, is eligible to get a Special Pension for the period w.e.f. 03/04/2022 to 01/03/2026.

**And**

**Whereas,** the last basic pay of Late Sulayham Reang, Ex-Group-D, was Rs.16200/- and as per **PPO No.142551448 dated 01/05/2025** the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E) Tripura @ Rs.16200/- P.M for the period w.e.f 03/04/2022 to 02/04/2032.

Now, therefore the provisional special pension is hereby sanctioned in favour of Smt. Kuchi Rung Reang, W/O.Late. Sulayham Reang, Ex-Group-D amounting to Rs.16200/- + 3%Admissible DR w.e.f 03/04/2022 to 30/06/2022 & Rs (32400-16200)=Rs.16200/- + Admissible DR+8%. w.e.f 01/07/2022 to 30/11/2022 & Rs.(32400-16200)=Rs.16200/- + Admissible DR +20%. w.e.f 01/12/2022 to 30/06/2024 & Rs(32400-16200)=Rs.16200/-+ Admissible DR+25%. w.e.f 01/07/2024 to 31/10/2024 & Rs(32400-16200)=Rs.16200/- + Admissible DR+30%. w.e.f 01/11/2024 to 31/03/2025 & Rs(32400-16200)=Rs.16200/- + Admissible DR+33% w.e.f 01/04/2025 to time to time increase in DR up to 01/03/2026.subject to finalization by the Accountant General (A&E) Tripura and the amount will be debitale under Head of Account 2071-Pension & Other benefits,01-Civil,105-Family Pension 02-Pension, 01- General Pension,04-Pensionary Charges (2271-01-105-02-01-04).
