Whereas, Sri Debraj Das,LDC of Directorate of Elementary Education, Tripura joined in Govt. Service on 01/04/2015;

AND

Whereas, it is observed that Sri Debraj Das, LDC had remained absent from duties since 01/03/2020 to till date in an unauthorized manner.

AND

Whereas, in this regard concerned HO & DDO has issued three show cause memos to Sri Debraj Das,LDC vide dated 05/02/2020, 05/05/2020, and 01/06/2020 but he did not responded as appeared from report of HO & DDO dated 08/06/2020.

AND

Whereas, this Directorate 02(two)nos. show cause notice were issued to Sri Debraj Das, LDC viz from 24/06/2020 and 21/06/2021.

AND

Whereas, issued 1st show cause dated 24/06/2020 to Sri Debraj Das,LDC directing him to resume duty by 30th June 2020 and submit written statement regarding the causes of his unauthorized absence was sent by which was received by his wife Smt. Dipa Das on 25/06/2020, but no response received till date from him.

AND

Whereas, issued 2nd show cause dated 21/06/2021 to Sri Debraj Das, LDC wherein he was asked to explain within 7(seven) days of receipt of the Memo as to why he should not be treated as deemed have resigned from Govt. service as per notification No.F.1(1)-FIN(G)/86 dated 20/06/2013 of the Finance Department and Memorandum vide No.F.20(1)/GA(P&T)/18(Part) dated 12/12/2018 of the General Administration (P&T) Department was sent messenger which was received by his father on 28/06/2021, but no response received from him.


AND

Whereas, from all of the above it appears that Sri Debraj Das, LDC has been neglecting his duties which is unbecoming on the part of a Government employee ;

AND

Whereas, notification No.F.1(1)-FIN(G)/86 dated 20/06/2013 of the Finance Department and Memorandum vide No.F.20(1)/GA(P & T)/18 (Part) dated 12/12/2018 of the General Administration (P & T) Department, Government of Tripura states that a Government servant shall be deemed to have resigned from the service if – (a) is absent without authorization a period of 1 (One) year; or (b) remains absent from duty for a continuous period of 5 (Five) years, with or without Leave ;

Now, through this memo which is being published in a local leading newspaper & website of the Department Sri Debraj Das, LDC is hereby asked to explain within 07/03/2022 as to why he should not be considered as deemed to have resigned from Government Service ,failing which action will be taken *ex parte*.
