They should report for their duties at the places of transfer and submit joining report to the Head of Office concerned as indicated each in Col. No.3.

In this regard, it is to be mentioned here that as per report available from the DEOs concerned 04 (Four) Nos. Teachers have not been entrusted for any election related duty. However, if any of these teachers have been entrusted with election related works by competent authority in interim period then they will continue in their existing place of posting till completion of Election process. All the concerned DEOs and Head of Offices/DDOs are requested to ensure this. However, other teacher who has not yet been assigned with election duty may be treated as relased from their existing place of posting w.e.f the afternoon of 18.01.2023.

Again, in conformity with earlier issued direction all the concerned DDO & Head of Office are requested to take up with respective office of the SDM for inclusion of name of teacher concerned with respect to destination school and exclusion from surce school in the data base after execution of transfer order.

Their pay and allowances etc. will be drawn against the Head of Account under which their pay and allowances etc. are usually drawn.

Concerned Head of Office & DDO, are requested to send the LPC/Service Book/Personal file etc. of the employee concerned to the Head of Office & DDO, as noted in Col. No. 3 against each in due course under intimation to this Directorate.
