Subject: - **Offer of appointment to the post of Under Graduate Teacher - Posting thereof.**

Reference: - Memo. No.F.1 (1-1)-DEE/ESTT/2022(L-23) dated 08/11/2022 and 09/11/2022.

387 (Three Hundred Eighty Seven) persons as per list attached herewith who were offered to the post of Under Graduate Teacher on a fixed monthly pay of **Rs, 16,050/- (revised) (Rupees Sixteen thousand Fifty)** only vide above reference and who have accepted the offers of appointment are hereby posted to the school as noted against each in column No.3 of the list (Annexure-A)

They should report for their duty at the office of the respective District Education Officer pertaining to concerned School on **06/12/2022 or 07/12/2022** and submit joining report.

The concerned District Education Officers are requested to re direct them to their respective place of posting as mentioned in Col.3 and report to concerned Head of Office & DDO,

The in-service candidates must furnish their "Acceptance of Resignation/Release Order" from their respective Head of Department to the concerned District Education Officers at the time of joining.

The appointment is further subject to verification of character and antecedents by the competent authority in due course of time.

As per Notification of the Finance Department, Tripura vide No.F.8 (1) -FIN (G)/2004(P-1)/108-305 dated 13.7.2018, **the Government Servants joining the service of the State Government or after 1<sup>st</sup> July, 2018 shall not be governed by the existing Central Civil Services (Pension) Rules, 1972 (as adopted in the State of Tripura) and orders issued there under from time to time. So far as their pension and other retirement benefits are concerned, they will be governed by a new set of Pension Rules, which are being formulated in line with the Contributory Pension Scheme announced by Government of India.**

The persons concerned are therefore, required to furnish an undertaking as per specimen enclosed herewith along with their joining report.

As per NCTE notification dated 28 June, 2018, the persons who acquired the qualification of Bachelor of Education from any recognized institution shall be considered for appointment as a teacher in classes I-V provided the person so appointed as a teacher shall mandatorily undergo a six months bridge course in Elementary Education from an Institution recognized by NCTE within two years of such appointment as primary teacher.

If any of the candidate fails to join his / her place of posting within the period as mentioned above or in the event of submission of wrong / false certificate/information, the offer of appointment issued in his / her favour shall be cancelled.

No T.A. /D.A. will be allowed for joining the post.
