Sub: Sanctioning Provisional Special Pension in favour of Smt Basanti Rani Jamatia W/O Late Mohan Lal Jamatia, Ex- KBT of Sardar Para High (Pry) School under HO & DDO HM of Sardar Para High School, Udaipur, Gomati, Tripura.

Whereas, Late Mohan Lal Jamatia, Ex-KBT of Sardar Para High (Pry) School under HO & DDO HM of Sardar Para High School, Udaipur, Gomati, Tripura expired on **02/03/2022** while in service, the case comes under the purview of the 'Scheme for Compassionate Appointment/ Benefit of Government employees of Tripura' vide Notification of the GA(P&T) Department No.F.1(1)-GA(P&T)/18, dated 02/03/2019.

And

Whereas, Late Mohan Lal Jamatia, Ex- KBT expired at the age of 56 years 10 month and there is no earning member in the family at the time of death on **02/03/2022** as per the report of the SDM Udaipur, Gomati Tripura. His wife Smt Basanti Rani Jamatia is entitled under **Support Category-1** in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till her deceased husband would have attained 60 years of age.

And

Whereas, as per the service record the date of birth of Late Mohan Lal Jamatia, Ex- KBT is **02/05/1965** and as per the Notification of the GA(P&T) Department dated 02.03.2019 his wife Smt Basanti Rani Jamatia is eligible to get a Special Pension for the period w.e.f 03/03/2022 to 01/05/2025.

And

Whereas, the last basic pay of Late Mohan Lal Jamatia, Ex- KBT was Rs.60800/- and as per **PPO No.142445702 dated 13/02/2023** the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E) Tripura @ Rs.30400/-P.M for the period w.e.f 03/03/2022 to 02/03/2032.

Now, therefore the provisional special pension has been sanctioned in favour of Smt Basanti Rani Jamatia W/O Late Mohan Lal Jamatia, Ex-KBT Rs (60800-30400)=Rs.30400/ + Admissible DR 3% w.e.f 03/03/2022 to 30/06/2022. Rs(60800-30400)=Rs.30400/ + Admissible DR 8% w.e.f 01/07/2022 to 30/11/2022. Rs (60800-30400)=Rs.30400/ + Admissible DR 20% w.e.f 01/12/2022 to 30/06/2024. Rs (60800-30400) = Rs.30400/ + Admissible DR 25% w.e.f 01/07/2024 to 31/10/2024 Rs (60800-30400)=Rs.30400/+Admissible DR 30% w.e.f 01/11/2024 to 31/03/2025 & Rs (60800-30400)= Rs.30400/+ Admissible DR 33% w.e.f 01/04/2025 to 01/05/2025 .Subject to finalization by the Accountant General (A&E) Tripura and the amount will be debatable under Head of Account 2071-Pension & Other benefits, 01-Civil, 105-Family Pension 02-Pension, 01- General Pension, 04-Pensionary Charges (2271-01-105-02-01-04).
