Sub:- Sanctoning Provisional Special Pension in favor of Smt. Bina Sukla Das, W/O Late. Arun Kumar Das, Ex-UGT of Dalugaon H.S School Kailashahar Unakoti Tripura.

Whereas, Late. Arun Kumar Das, Ex-UGT of Dalugaon H.S School Kailashahar Unakoti Tripura expired on 10/01/2025 while in service, the case comes under the purview of the Scheme for Compassionate appointment/Benefit of Government employees of Tripura Notification of GA (P & T) Department No. F. 1(1)-GA(P&T)/18, Dated 02/03/2019.

And

Whereas, Late. Arun Kumar Das, Ex-UGT expired at eh age of 58 years 09 months 16 days and there is no earning member in the family as per the report of the SDM, Jirania, West Tripura. His wife Smt. Bina Sukla Das, is entitled under **Support Category-1** in accordance with the Notification of the GA(P&T) Department vide No. F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till her deceased husband would have attained 60 years of age.

And

Whereas, as per the service record the date of birth of Late Arun Kumar Das, Ex-UGT, is 25/03/1966 and as per the Notification of the GA(P & T) Department dated 02/03/2019 his wife Smt. Bina Sukla Das, is eligible to get a Special Pension for the period w.e.f. 11/01/2025 to 24/03/2026.

And

Whereas, the last basic pay of Late Arun Kumar Das, Ex-Group-D, was Rs. 50700/- and as per **PPO No.142552563 Dated 14/07/2025** the enhanced family pension (EFP) has be sanctioned by the Accountant General (A&E) Tripura @ Rs. 25350/-P.M. for the period w.e.f. 11/01/2025 to 24/03/2033.

Now, therefore the provisional special pension has been sanctioned in favor of Smt. Bina Sukla Das, W/O Late Arun Kumar Das, Ex.-UGT for Rs. (50700 - 25350)= Rs.25350/- + Admissible DR @ 30% w.e.f. 11/01/2025 to 31.03.2025 & Rs. (50700 - 25350)= Rs.25350/- + Admissible DR @ 33% w.e.f. 01/04/2025 to 30/09/2025 & Rs. (50700 - 25350)= Rs.25350/- + Admissible DR @ 36% w.e.f. 01/10/2025 to time to time increase of DR up to 24/03/2026 subject to finalization by the Accountant General (A&E) Tripura and the amount will be debit able under Head of Account 2071-Pension & Other benefits, 01-Civil, 105-Family Pension, 02 Pension, 01-General Pension, 04-Pensionary Charges (2071-01-105-02-01-04).
