**Sub:** -Sanctioning Provisional Special Pension in favour of Smt Chhaya Rani Debbarma, W/O Late Krishna Kanta Debbarma. Ex- A/T (Pry) of Bastali S.B School under HO & DDO Inspector of Schools, Bishalgarh, Sepahijala, Tripura.

**Whereas,** Late Krishna Kanta Debbarma. Ex- A/T (Pry) of Bastali S.B School under HO & DDO Inspector of Schools, Bishalgarh, Sepahijala, Tripura expired on **09/05/2019** while in service, the case comes under the purview of the 'Scheme for Compassionate Appointment/ Benefit of Government employees of Tripura' vide Notification of the GA(P&T) Department No.F.1(1)-GA(P&T)/18, dated 02/03/2019.

**Whereas,** Late Krishna Kanta Debbarma Ex-A/T(Pry) expired at the age of 56 years 03 month 08 days and there is no earning member in the family as per the report of the SDM, Bishalgarh, Sepahijala, Tripura. His wife Smt Chhaya Rani Debbarma is entitled under **Support Category-1** in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till her deceased husband would have attained 60 years of age.

**Whereas,** as per the service record the date of birth of Late Krishna Kanta Debbarma. Ex- A/T (Pry) is **01/02/1963** and as per the Notification of the GA(P&T) Department dated 02.03.2019. His wife Smt Chhaya Rani Debbarma is eligible to get a Special Pension for the period w. e. f. 10/05/2019 to 31/01/2023.

**And**

**Whereas,** the last basic pay of Late Krishna Kanta Debbarma Ex-A/T was Rs.66400/- and as per **PPO No.142026964** the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E), Tripura @ Rs.33200/- P.M for the period w. e. f. 10/05/2019 to 09/05/2029.

Now, therefore the provisional special pension has been sanctioned in favour of Smt Chhaya Rani Debbarma W/O Late Krishna Kanta Debbarma, Ex-A/T (Pry) Rs (66400-33200)= Rs.33200/- + Admissible DR w.e.f 10/05/2019 to 28/02/2021 & Rs(66400-33200)= Rs.33200/- + Admissible DR 3% w.e.f 01/03/2021 to 30/06/2022 & Rs (66400-33200)= Rs.33200/- + Admissible DR 8% DA w.e.f 01/07/2022 to 30/11/2022 & Rs (66400-33200)= Rs.33200/- + Admissible DR 20% DA w.e.f 01/12/2022 to 31/01/2023 subject to finalization by the Accountant General (A&E) Tripura and the amount will be debitale under Head of Account 2071-Pension & Other benefits, 01-Civil, 105-Family Pension 02-Pension, 01- General Pension, 04-Pensionary Charges (2271-01-105-02-01-04).
