Sub: Sanctioning Provisional Special Pension in favour of Smt Daina Molsom D/O Late Pradip Kumar Molsom, Ex-KBT of Debtamura High (Pry) School under HO & DDO Inspector of Schools Udaipur, Gomati, Tripura.

Whereas, Late Pradip Kumar Molsom, Ex-KBT of Debtamura High (Pry) School under HO & DDO Inspector of Schools, Udaipur, Gomati Tripura expired on **14/07/2019** while in service, the case comes under the purview of the 'Scheme for Compassionate Appointment/ Benefit of Government employees of Tripura' vide Notification of the GA(P&T) Department No.F.1(1)-GA(P&T)/18, dated 02/03/2019.

And

Whereas, Late Pradip Kumar Molsom, Ex-KBT expired at the age of 50 years 05 month 09 days and there is no earning member in the family as per the report of the SDM Udaipur, Gomati, Tripura. His daughter Smt Daina Molsom is entitle under **Support Category-1** in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till her deceased father would have attained 60 years of age.

And

Whereas, as per the service record the date of birth of Late Pradip Kumar Molsom, Ex-KBT is **05/02/1969** and as per the Notification of the GA(P&T) Department dated 02.03.2019. His daughter Smt Dania Molsom is eligible to get a Special Pension for the period w.e.f 15/07/2019 to 04/02/2029. or till her marriage whichever is earlier.

And

Whereas, the last basic pay of Late Pradip Kumar Molsom, Ex-KBT was Rs.54000/- and as per **PPO No.142028592 dated 29/06/2020** the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E), Tripura @ Rs.23900/- P.M for the period w.e.f 15/07/2019 to 14/07/2029. or till her marriage whichever is earlier.

Now, therefore the provisional special pension has been sanctioned in favour of Smt Daina Molsom D/O Late Pradip Kumar Molsom, Ex-KBT of Rs (54000-27000)= Rs.27000/- + Admissible DR + DA time to time admissible w.e.f 15/07/2019 to 04/02/2029 or till her marriage whichever is earlier. Subject to finalization by the Account General (A&E) Tripura and the amount will be debatable under Head of Account 2071-Pension & Other benefits, 01-Civil, 105-Family Pension 02-Pension, 01- General Pension, 04-Pensionary Charges (2271-01-105-02-01-04).
