Sub:- Sanctoning Provisional Special Pension in favor of Sri Debabrata Bhattacharya, H/O. Late. Pritha Debbarma, Ex-UGT of Arundhutinagar H.S. School, Agartala, West Tripura under HO & DDO, Inspector of Schools, Sadar-A, West Tripura.

Whereas, Late. Pritha Debbarma, Ex-UGT of Arundhutinagar H.S. School, Agartala, West Tripura under HO & DDO, Inspector of Schools, Sadar-A, West Tripura expired on 31/01/2025 while in service, the case comes under the purview of the Scheme for Compassionate Appointment/Benefit of Government employees of Tripura Notification of GA (P & T) Department No. F. 1(1)-GA(P&T)/18, Dated 02/03/2019.

And

Whereas, Late. Pritha Debbarma, Ex-UGT expired at the age of 56 years 03 months 28 days and there is no earning member in the family as per the report of the SDM, Sadar, West Tripura. Her husband, Sri Debabrata Bhattacharya, is entitled under **Support Category-1** in accordance with the Notification of the GA (P&T) Department vide No. F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till his deceased wife would have attained 60 years of age.

And

Whereas, as per the service record the date of birth of Late. Pritha Debbarma, Ex-UGT, is 03/10/1968 and as per the Notification of the GA(P & T) Department dated 02/03/2019 her husband, Sri Debabrata Bhattacharya, is eligible to get a Special Pension for the period w.e.f. 01/02/2025 to 02/10/2028.

And

Whereas, the last basic pay of Late Pritha Debbarma, Ex-UGT, was Rs. 50700/- and as per **PPO No.142552609 Dated 23/07/2025** the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E) Tripura @ Rs. 25350/-P.M. for the period w.e.f. 01/02/2025 to 31/01/2035.

Now, therefore the provisional special pension has been sanctioned in favor of Sri Debabrata Bhattacharya, H/O Late Pritha Debbarma, Ex.-UGT for Rs. (50700-25350)= Rs.25350/- + Admissible DR @30% w.e.f. 01/02/2025 to 31.03.2025 & Rs. (50700-25350)= Rs.25350/- + Admissible DR @33% w.e.f. 01/04/2025 to 30/09/2025 & Rs. (50700-25350)= Rs.25350/- + Admissible DR @36% w.e.f. 01/10/2025 to time to time increase of DR up to 02/10/2028 subject to finalization by the Accountant General (A&E) Tripura and the amount will be debit able under Head of Account 2071-Pension & Other benefits, 01-Civil, 105-Family Pension, 02 Pension, 01-General Pension, 04-Pensionary Charges (2071-01-105-02-01-04).
