Though Saturday is holiday for CBSE affiliated Vidyajyoti Schools, one examination date for class III to VIII is scheduled on 17-02-2024. Hence all the schools including Vidyajyoti Schools shall remain open on 17-02-2024 (Saturday).

The Question papers shall be of **80 Marks** for above subjects and shall be framed and supplied by the Centralized Examination unit for Elementary level on the basis of basic skills (pre class concept covering foundational literacy and numeracy) and syllabus of concerned classes.



Except the above cited subjects, Hindi/Sanskrit for Class VII and VIII, Other Minority Languages for the concerned classes and Arabic/Urdu in Madrassas of classes of III-VIII shall be framed by the respective School Authority like previous years and Examination on the above cited subjects will be taken on the day convenient to the respective School Authority.

Prescribed provision for allowing compensatory time @ 20 minutes per hour to the students with benchmark disabilities has to be complied. Student who desires to avail the benefit will have to produce the disability certificate issued by the Competent Authority.
