The case comes under the purview of the 'Scheme for Compassionate Appointment/ Benefit of Government employees of Tripura' vide Notification of the GA(P&T) Department No.F.1(1)-GA(P&T)/18, dated 02/03/2019.

**Whereas,** Lt Kirti Sadhan Jamatia, Ex-KBT expired at the age of 57 years 05 month 23 days and there is no earning member in the family as per the report of the SDM, Amarpur, Gomati, Tripura his wife Smt. Hirabati Jamatia is entitle under **Support Category-1(one)** in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till her deceased husband would have attained 60 years of age.



**Whereas,** as per the service record the date of birth of Lt. Kirti Sadhan Jamatia Ex-KBT is **25/02/1964** and as per the Notification of the GA(P&T) Department dated 02.03.2019, his wife Smt Hirabati Jamatia is eligible to get a Special Pension for the period w.e.f 19/08/2021 to 24/02/2024.

And

**Whereas,** the last basic pay of Lt Kirti Sadhan Jamatia Ex-KBT was Rs.59000/- and as per PPO No.142238187 dated 05-07-2022 the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E), Tripura @ Rs.29500/- P.M for the period w.e.f 19/08/2021 to 24/02/2031.

**Now,** therefore the provisional special pension has been sanctioned in favour of Smt. Hirabati Jamatia W/O Late Kirti Sadhan Jamatia Ex-KBT @ Rs (59000-29500)= Rs 29500/- + Admissible DR+ 3% DA w.e.f 19/08/2021 to 30/06/2022 & @ Rs (59000-29500)=Rs 29500/-+Admissible DR+ 8% DA w.e.f 01/07/2022 to 30/11/2022 & @ Rs (59000-29500)=Rs 29500/- + Admissible DR+ 20% DA w.e.f 01/12/2022 to 24/02/2024 subject to finalization by the Account General (A&E) Tripura and the amount will be debit able under Head of Account 2071-Pension & Other benefits, 01-Civil, 105-Family Pension 02-Pension, 01- General Pension, 04-Pensionary Charges (2271-01-105-02-01-04).
