Whereas, Late Ditendra Jamatia.Ex-UGT under HO & DDO Inspector of Schools, Jolaibari, Tripura, South expired on **09/02/2023** while in service, the case comes under the purview of the 'Scheme for Compassionate Appointment/ Benefit of Government employees of Tripura' vide Notification of the GA(P&T) Department No.F.1(1)-GA(P&T)/18, dated 02/03/2019.

Whereas, Lt Ditendra Jamatia, Ex-UGT expired at the age of 52 years 08 month 27 days and there is no earning member in the family as per the report of the SDM, Udaipur, Gomati District his wife Smt.Subhash Rani Jamatia is entitle under **Support Category-1** in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till her deceased husband would have attained 60 years of age.

Whereas, as per the service record the date of birth of Lt Ditendra Jamatia.Ex-UGT is **12/05/1970** and as per the Notification of the GA(P&T) Department dated 02.03.2019, his wife Smt Subhash Rani Jamatia is eligible to get a Special Pension for the period w. e. f. 10/02/2023 to 11/05/2030.

Whereas, the last basic pay of Lt Ditendra Jamatia, Ex- UGT was Rs.47800/- and as per **PPO No.142445909** dated 27-02-2024 the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E), Tripura @ Rs.23900/- P.M for the period w. e. f. 10/02/2023 to 09/02/2033.

Now, therefore the provisional special pension has been sanctioned in favour of Smt. Subhash Rani Jamatia, W/O.Late Ditendra Jamatia. Ex-UGT@ Rs (47800-23900)= Rs.23900/- + Admissible DR+20% DA w.e.f 10/02/2023 to 31/12/2023 & Rs (47800-23900)=Rs.23900/- + Admissible DR +25% DA w.e.f. 01/01/2024 to 11/05/2030.Subject to finalization by the Account General (A&E) Tripura and the amount will be debit able under Head of Account 2071-Pension & Other benefits, 01-Civil, 105-Family Pension 02-Pension, 01- General Pension,04-Pensionary Charges (2271-01-105-02-01-04).
