Whereas, Lt Arabinda Das Ex- A/T of Rajarbag S/B School under HO & DDO Inspector of Schools Udaipur, Gomati, Tripura expired on 18/12/2021 while in service, the case comes under the purview of the 'Scheme for Compassionate Appointment/ Benefit of Government employees of Tripura' vide Notification of the GA(P&T) Department No.F.1(1)-GA(P&T)/18, dated 02/03/2019.

And

Whereas, Lt Arabinda Das Ex- A/T expired at the age of 58 years 10 month 15 days and there is no earning member in the family as per the report of the SDM, Udaipur, Gomati, Tripura his wife Smt Milan Das is entitle under **Support Category-1** in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till her deceased husband would have attained 60 years of age.

Whereas, as per the service record the date of birth of Lt. Arabinda Das Ex- A/T is 03/02/1963 and as per the Notification of the GA(P&T) Department dated 02.03.2019, his wife Smt Milan Das is eligible to get a Special Pension for the period w.e.f. 19/012/2021 to 02/02/2023.

And

Whereas, the last basic pay of Lt Arabinda Das Ex- A/T was Rs.74800/- and as per PPO No.142238653 dated 10-08-2022 the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E), Tripura @ Rs.37400/- P.M for the period w.e.f. 19/012/2021 to 02/02/2030.

Now, therefore the provisional special pension has been sanctioned in favour of Smt Milan Das W/O Late Arabinda Das Ex- A/T @ Rs (74800-37400) = Rs 37400/- + Admissible DR + 3% DA w.e.f 19/012/2021 to 30/06//2022 & Rs(74800-37400)=Rs 37400/- + Admissible DR + 8% DA w.e.f 01/07/2022 to 30/11/2022 & R s(74800-37400)= Rs 37400/- + Admissible DR + 20 % DA w.e.f 01/12/2022 to 02/02/2023 subject to finalization by the Account General (A&E) Tripura and the amount will be debit able under Head of Account 2071-Pension & Other benefits, 01-Civil, 105-Family Pension 02-Pension, 01- General Pension, 04-Pensionary Charges (2271-01-105-02-01-04).
