MEMORANDUM

Whereas, Sri Ajit Datta, LDC of Education Inspectorate, Satchand & SNP, Sabroom, South Tripura 1st joined in Govt. Service on 16/12/2013(F/N) ;

AND

Whereas, Sri Ajit Datta, LDC of Education Inspectorate, Satchand & SNP, Sabroom, South Tripura had remained absent from duties since 06/09/2023 to till date without any intimation, as informed by the Inspector of Schools, Satchand & SNP Sabroom, South Tripura.

AND

Whereas, on 28/02/2024 this Directorate had issued show cause notice to Sri Ajit Datta, LDC of Education Inspectorate, Satchand & Sabroom N.P., South Tripura which was received by Smt. Debi Bal(Datta) the mother of Sri Ajit Datta, LDC on 13/03/2024 via registered post with AD RE 414983000IN. The IS Satchand has informed that till date no response of the showcause notice has been received from Sri Ajit Datta in this matter. On 19/08/2024 this Directorate had again issued a show cause notice to Sri Ajit Datta, LDC of Education Inspectorate, Satchand & Sabroom N.P., South Tripura via Registered Post (ADRE 4074916931IN). In this regard a note was received from the Postmaster indicating that the AD card was undeliverable due to the addressee being out of station, and the door was locked. The card was returned to this office on 13/09/2024. The lack of communication on the part of Sri Datta raises concerns about his commitment to his duties.

AND

Whereas, it appears that Sri Ajit Datta, LDC has been neglecting his duty wilfully which is unbecoming on the part of a Govt. employee and as per notification No.F.1(1)-FIN(G)/86 dated 20/06/2013 of the Finance Department and Memorandum vide No.F.20(1)/GA(P & T)/18 (Part) dated 12/12/2018 of the General Administration (P & T) Department, Government of Tripura a Government servant shall be deemed to have resigned from the service if he is

(a) absent without authorization for a period of 1 (One) year; or

(b) remains absent from duty for a continuous period of 5 (Five) years, with or without Leave ;

Now, therefore, therefore this memorandum is being published in a local daily news paper and in the website of the Department and Sri Ajit Datta, LDC of Education Inspectorate, Satchand & SNP, Sabroom, South Tripura is now hereby asked to explain within 31/12/2024 as to why he should not be considered as deemed to have resigned from the service, falling which action will be taken *exparte*
