His wife Smt Dalimba Roy (Debnath) is entitled under Support Category-1 in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till her deceased husband would have attained 60 years of age.

Whereas, as per the service record the date of birth of Late Parimal Debnath, Ex-UGT is 02/06/1969 and as per the Notification of the GA(P&T) Department dated 02.03.2019 his wife Smt Dalimba Roy(Debnath) is eligible to get a Special Pension for the period w.e.f 19/12/2022 to 01/06/2029.

Whereas, the last basic pay of Late Parimal Debnath, Ex-UGT was Rs.46400/- and as per PPO No.142341655 dated 12/04/2023 the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E)Tripura @ Rs.23200/-P.M for the period w.e.f 19/12/2022 to 18/12/2032.

Now, therefore the provisional special pension has been sanctioned in favour of Dalimba Roy (Debnath), W/O Late Parimal Debnath, Ex-UGT of Rs(46400-23200)= Rs.23200/- + Admissible+ DR 20%.w.e.f 19/12/2022 to 31/12/2023 & Rs(46400-23200)= Rs.23200/- + Admissible DR25% w.e.f 01/01/2024 to 31/10/2024 & Rs (46400-23200)= Rs.23200/- + Admissible DR 30% w.e.f 01/11/2024 to time to time increase DA up to 18/12/2032 subject to finalization by the Accountant General (A&E) Tripura and the amount will be debitable under Head of Account 2071-Pension & Other benefits,01-Civil,105-Family Pension 02-Pension, 01- General Pension,04-Pensionary Charges (2271-01-105-02-01-04).
