Whereas, Late Satya Ranjan Tripura Ex-, Gr-D expired at the age of 50 years 06 month 10 days and there is no earning member in the family at the time of death on 15/01/2023 as per the report of the SDM GondaTwisa, Dhalai, Tripura. His wife Smt Rani Tripura is entitled under Support Category-1 in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till her deceased husband would have attained 60 years of age.

Whereas, as per the service record the date of birth of Late Satya Ranjan Tripura Ex-,Gr-D is 05/07/1972 and as per the Notification of the GA(P&T) Department dated 02.03.2019. His wife Smt Rani Tripura is eligible to get a Special Pension for the period w.e.f 16/01/2023 to 04/07/2032.

Whereas, the last basic pay of Late Satya Ranjan Tripura Ex-,Gr-D was Rs.35400/- and as per PPO No.142344666 dated 22/11/2023 the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E)Tripura @ Rs.17700/-P.M for the period w.e.f 16/01/2023 to 15/01/2033.

Now, therefore the provisional special pension has been sanctioned in favour of Smt Rani Tripura W/O Late Satya Ranjan Tripura Ex-,Gr-D of Rs (35400–17700)=Rs.17700/- + Admissible DR 20%.w.e.f 16/01/2023 to 31/12/2023 & Rs (35400–17700)=Rs.17700/- + Admissible DR 25%.w.e.f 01/01/2024 to 31/10/2024 & Rs (35400–17700)= Rs.17700/- + Admissible DR 30% w.e.f 01/11/2024 to time to time increase DA/DR up to 04/07/2032 subject to condition to finalization by the Accountant General (A&E) Tripura and the amount will be debitable under Head of Account 2071-Pension & Other benefits,01-Civil,105-Family Pension 02-Pension, 01- General Pension,04-Pensionary Charges (2271-01-105-02-01-04).
