MEMORANDUM

Whereas, Sri Diptanu Dey, GT joined service on 27/07/2021 (forenoon) at District Education Office, Udaipur, Gomati, Tripura and he was released on 27/07/2021 (after-noon) from DEO, Gomati Dist. Tripura with an instruction to join his new place of posting at Gangachara H.S School, Udaipur, Gomati Tripura by 28/07/2021 positively vide No.F.1(3-3B) EDN (G)/Estt. /18 /7741-43 dated 27/07/2021.

AND

Whereas, Sri Diptanu Dey, GT reported for his duty on 28/07/2021 at Gangachara H.S School, Udaipur, Gomati Tripura.

AND

Whereas, Sri Diptanu Dey, GT joined in Gangachara H.S School on 28/07/2021 but after joining he was absent from duty to till today without prior permission as informed by the Headmaster, Gangachara H.S School vide letter dated 16/03/2023. On 23/03/2023 this Directorate had issued a letter to the Headmaster, Gangachara H.S School, Udaipur, Gomati Tripura in respect of Sri Diptanu Dey, GT for information/documents and to furnish a detailed report along with the views of the DDO. But no response has been received from HM concerned. On 25/08/2023 this Directorate had issued reminder to the Headmaster, Gangachara H.S School for the said matter. The Headmaster, Gangachara H.S School, Udaipur, Gomati Tripura submitted information regarding Sri Diptanu Dey, GT vide letter dated 20/11/2023 that Sri Diptanu Dey, GT had been remaining absent from duties w.e.f. 29/07/2021 to till date without any prior information of the concerned authority.

AND

Whereas On 04/12/2023 this Directorate issued show cause notice to Sri Diptanu Dey, GT and directed him to join the duty within 31st December, 2023 at Gangachara H.S School, Udaipur, Gomati Tripura and he was also asked to explain as to why the period of absence from 29/07/2021 to prior the date of re-joining should not be treated as Dies Non for all purpose without forfeiture of his past service but he did not join his duties and did not submit any explanation till date as informed by the HO & DDO.

AND

Whereas On 17/01/2024 (at P/25, 26) once again this Directorate issued show cause to Sri Diptanu Dey, GT and asked him to explain as to why he should not be deemed to have resigned from the service due to unauthorized absence from duty since 29/07/2021 to till date continuously for a period more than 02 years. But no response has been received from him till date.

AND

Whereas, it appears that Sri Diptanu Dey, GT has been neglecting his duty willfully which is unbecoming on the part of a Govt. employee and as per notification No.F.1(1)-FIN(G)/86 dated 20/06/2013 of the Finance Department and Memorandum vide No.F.20(1)/GA(P & T)/18 (Part) dated 12/12/2018 of the General Administration (P & T) Department, Government of Tripura a Government servant shall be deemed to have resigned from the service if he is

- (a) absent without authorization for a period of 1 (One) year; or
 (b) remains absent from duty for a continuous period of 5 (Five) years, with or without Leave.

Now, therefore, this memorandum is being published in a local daily news paper and in the website of the Department and Sri Diptanu Dey, GT of Gangachara H.S School, Udaipur, Gomati Tripura is now hereby asked to explain within 31/03/2025 as to why he should not be considered as deemed to have resigned from the service, failing which action will be taken *exparte*.
