Sub: Sanctioning Provisional Special Pension in favour of Smt Arnabati Reang, W/O Late Dhananjoy Reang, Ex-, Gr-D of Chawmanu Govt Eng Med Model School under HO & DDO Inspector of Schools (State) Chailengta, LTV, Dhalai Tripura.

Whereas, Late Dhananjoy Reang, Ex-, Gr-D of Chawmanu Govt Eng Med Model School under HO & DDO Inspector of Schools (State) Chailengta, LTV, Dhalai Tripura expired on **21/06/2023** while in service, the case comes under the purview of the 'Scheme for Compassionate Appointment/ Benefit of Government employees of Tripura' vide Notification of the GA(P&T) Department No.F.1(1)-GA(P&T)/18, dated 02/03/2019.

And

Whereas, Late Dhananjoy Reang, Ex-, Gr-D expired at the age of 52 years 05 months 20 days and there is no earning member in the family at the time of death on **21/06/2023** as per the report of the SDM LTV Chailengta, Dhalai Tripura. His wife Smt Arnabati Reang is entitled under **Support Category-1** in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till her deceased husband would have attained 60 years of age.

And

Whereas, as per the service record the date of birth of Late Dhananjoy Reang, Ex-, Gr-D is **01/01/1971** as per the Notification of the GA(P&T) Department dated 02.03.2019. His wife Smt Arnabati Reang is eligible to get a Special Pension for the period w.e.f 22/06/2023 to 31/12/2030.

And

Whereas, the last basic pay of Late Dhananjoy Reang, Ex-, Gr-D was Rs.34400/- and as per **PPO No.142447102 dated 17/05/2024** the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E) Tripura @ Rs.17200/- P.M for the period w.e.f 22/06/2023 to 21/06/2033.

Now, therefore the provisional special pension has been sanctioned in favour of Arnabati Reang, W/O Late Dhananjoy Reang, Ex-, Gr-D of Rs (34400-17200)= Rs.17200/- + Admissible DR 20% w.e.f 22/06/2023 to 30/06/2024 & Rs (34400-17200)= Rs.17200/- + Admissible DR 25% w.e.f 01/07/2024 to 30/10/2024 & Rs (34400-17200)= Rs.17200/- + Admissible DR 30% w.e.f 01/11/2024 to time to time increase up to 31/12/2030. Subject to condition to finalization by the Accountant General (A&E) Tripura and the amount will be debatable under Head of Account 2071-Pension & Other benefits, 01-Civil, 105-Family Pension 02-Pension, 01- General Pension, 04-Pensionary Charges (2271-01-105-02-01-04).
