Whereas, Late.Rabindra Das, Ex-UGT expired at the age of 56 years 08 month 11 days and there is no earning member in the family as per the report of the SDM, Khowai, Tripura. His wife Smt.Lipika Paul(Das), is entitled under <u>Support Category-1</u> in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till her deceased husband would have attained 60 years of age.

Whereas, as per the service record the date of birth of Late Rabindra Das, Ex-UGT is **25/01/1966** and as per the Notification of the GA(P&T) Department dated 02.03.2019 his wife Smt.Lipika Paul(Das), is eligible to get a Special Pension for the period w.e.f 07/10/2022 to 24/01//2026.

Whereas, the last basic pay of Late Rabindra Das, Ex-UGT was Rs.47800/- and as per PPO No.142343623 dated 02/08/2023 the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E)Tripura @ Rs.23900/- P.M for the period w.e.f 07/10/2022 to 06/10/2032.

Now, therefore the provisional special pension has been sanctioned in favour of Smt.Lipika Paul(Das), W/O.Late.Rabindra Das, Ex-UGT, Rs(47800-23900)=Rs.23900/-+Admissible DR 8% w.e.f 07/10/2022 to 30/11/2022 & Rs(47800-23900)=Rs.23900/- + Admissible DR 20%. w.e.f 01/12/2022 to 31/12/2023 & Rs(47800-23900)=Rs.23900/- + Admissible DR 25%. w.e.f 01/07/2024 to 31/10/2024 & Rs(47800-23900)=Rs.23900/-+ Admissible DR 30%. w.e.f 01/11/2024 to time to time increase of DA up to 24/01/2026 subject to finalization by the Accountant General (A&E) Tripura and the amount will be debitable under Head of Account 2071-Pension & Other benefits,01-Civil,105-Family Pension 02-Pension, 01- General Pension,04-Pensionary Charges (2271-01-105-02-01-04).
