**Sub:** Sanctioning Provisional Special Pension in favour of Smt Swarnarita Debbarma W/O Late Sushen Kr Debbarma, Ex- UGT of Bharat CP SB School under HO & DDO Inspector of Schools Salema, Dhalai, Tripura.

**Whereas,** Late Sushen Kr Debbarma, Ex-UGT of Bharat CP SB School under HO & DDO Inspector of Schools, Salema, Dhalai, Tripura expired on **15/01/2023** while in service, the case falls under the purview of the 'Scheme for Compassionate Appointment/ Benefit to Government employees of Tripura' vide Notification of the GA(P&T) Department No.F.1(1)-GA(P&T)/18, dated 02/03/2019.

**And**

**Whereas,** Late Sushen Kr Debbarma, Ex- UGT expired at the age of 50 years 01 month and there was no earning member in the family at the time of death on **15/01/2023** as per the report of the SDM, Kamalpur, Dhalai, Tripura. His wife Smt Swarnarita Debbarma is entitled under **Support Category-1** in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefits until her deceased husband would have attained the age of 60 year.

**And**

**Whereas,** as per the service record the date of birth of Late Sushen Kr Debbarma, Ex-UGT is **15/12/1972** and as per the Notification of the GA(P&T) Department dated 02.03.2019 his wife Smt Swarnarita Debbarma is eligible to get a Special Pension for the period w.e.f 16/01/2023 to 14/12/2032.

**And**

**Whereas,** the last basic pay of Late Sushen Kr Debbarma, Ex-UGT was Rs.47800/- and as per **PPO No.142342646 dated 26/05/2023** the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E) Tripura @ Rs.23900/-P.M for the period w.e.f 16/01/2023 to 15/01/2033.

**Now,** therefore, the provisional Special Pension is hereby sanctioned in favour of Smt. Swarnarita Debbarma, W/O, Late Sushen Kr Debbarma, Ex-UGT, Rs.(47800-23900)=Rs.23900/+ Admissible DR 20% w.e.f 16/01/2023 to 30/06/2024, Rs (47800-23900) = Rs.23900/+Admissible DR 25% w.e.f 01/07/2024 to 31/10/2024, Rs (47800-23900) = Rs.23900/+Admissible DR 30% w.e.f 01/11/2024 to 31/03/2025 & Rs(47800-23900)=Rs.23900/ + Admissible DR 33% w.e.f 01/04/2025 to time to time increase up to 14/12/2032. Subject to finalization by the Account General (A&E) Tripura and the amount will be debatable under Head of Account 2071-Pension & Other benefits, 01-Civil, 105-Family Pension 02-Pension, 01-General Pension, 04-Pensionary Charges (2271-01-105-02-01-04).
