**Whereas,** Late.Sambhu Debbarma,Ex-HM(Pry) of Arianda Thakur Para J.B School, under HO & DDO, Inspector of Schools, Jirania, West Tripura. expired on **14/03/2023** while in service, the case comes under the purview of the 'Scheme for Compassionate Appointment/ Benefit of Government employees of Tripura vide Notification of the GA(P&T) Department No.F.1(1)-GA(P&T)/18, dated 02/03/2019.

**Whereas,** Late Sambhu Debbarma,Ex-HM(Pry) expired at the age of 58 years 01 month 00 days and there is no earning member in the family as per the report of the SDM Jirania, West Tripura. His wife Smt.Jaya Rani Debbarma, is entitled under **Support Category-1** in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till her deceased husband would have attained 60 years of age.

**Whereas,** as per the service record the date of birth of Late Sambhu Debbarma,Ex-HM(Pry) is **14/02/1965** and as per the Notification of the GA(P&T) Department dated 02.03.2019 his wife Smt.Jaya Rani Debbarma, is eligible to get a Special Pension for the period w.e.f 15/03/2023 to 13/02/2025.

**And**

**Whereas,** the last basic pay of Late Sambhu Debbarma,Ex-HM(Pry) was Rs.66400/- and as per PPO No.142343494 dated **24/07/2023** the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E) Tripura @ Rs.33200/- P.M for the period w.e.f 15/03/2023 to 13/02/2032.

Now, therefore the provisional special pension has been sanctioned in favour of Smt.Jaya Rani Debbarma, W/O.Late.Sambhu Debbarma, Ex-HM(Pry) Rs(66400-33200)=Rs.33200/- + Admissible DR 20% w.e.f 15/03/2023 to 31/12/2023 & Rs(66400-33200)=Rs.33200/- + Admissible DR 25% w.e.f 01/01/2024 to 31/10/2024 & Rs(66400-33200)=Rs.33200/- + Admissible DR 30% w.e.f 01/11/2024 to time to time increase DR up to 13/02/2025 subject to finalization by the Accountant General (A&E) Tripura and the amount will be debitabe under Head of Account 2071-Pension & Other benefits,01-Civil,105-Family Pension 02-Pension, 01- General Pension,04-Pensionary Charges (2271-01-105-02-01-04).
