Sub: Sanctioning Provisional Special Pension in favour of Sri Lalremmawia, H/O Late Lalbiakfeli Sailo Ex-A/T(Pry)of Kawnpui RCP High School under HO & DDO Inspector of Schools (State) Kanchanpur, North Tripura.

Whereas, Late Lalbiakfeli Sailo. Ex- A/T (Pry) of Kawnpui RCP High School under HO & DDO Inspector of Schools, (State) Kanchanpur North Tripura expired on 15/04/2023 while in service, the case comes under the purview of the 'Scheme for Compassionate Appointment/ Benefit of Government employees of Tripura' vide Notification of the GA(P&T) Department No.F.1(1)-GA(P&T)/18, dated 02/03/2019.

And

Whereas, Late Lalbiakfeli Sailo Ex-A/T(Pry) expired at the age of 54 years 10 months 02 days and there is no earning member in the family as per the report of the SDM, Kanchanpur North Tripura. Her husband Sri Lalremmawia is entitled under <u>Support Category-1</u> in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till his deceased wife would have attained 60 years of age.

And

Whereas, as per the service record the date of birth of Late Lalbiakfeli Sailo.Ex- A/T (Pry) is 13/06/1968 and as per the Notification of the GA(P&T) Department dated 02.03.2019 her husband Sri Lalremmawia is eligible to get a Special Pension for the period w. e. f. 16/04/2023 to 12/06/2028.

And

Whereas, the last basic pay of Late Lalbiakfeli Sailo Ex-A/T was Rs.62600/- and as per PPO No.142445265 dated 10/01/2024 the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E),Tripura @ Rs.31300/- P.M for the period w. e. f. 16/04/2023 to 15/04/2033.

Now, therefore the provisional special pension has been sanctioned in favour of Sri Lalremmawia H/O Late Lalbiakfeli Sailo,Ex-A/T (Pry) Rs (62600–31300)= Rs.31300/- + Admissible DR 20% w.e.f 16/04/2023 to 31/12/2023 & Rs (62600–31300)= Rs.31300/- + Admissible DR 25% w.e.f 01/01/2024 to 12/06/2028 subject to finalization by the Accountant General (A&E) Tripura and the amount will be debit able under Head of Account 2071-Pension & Other benefits, 01-Civil, 105-Family Pension 02-Pension, 01- General Pension,04-Pensionary Charges (2271-01-105-02-01-04).
