Whereas, Late Jagat Debbarma, Ex-H/M (Pry) expired at the age of 57 years 04 months and 01 day and there was no earning member in the family at the time of death on 12/06/2024 as per report of the SDM, Mohanpur, Tripura West. His wife Smt Mani Debbarma is entitled under <u>Support Category-1</u> in accordance with the Notification of the GA(P&T) Department videNo.F.1(1)- GA(P&T)/18,dated 02/03/2019 and is eligible to receive Special Pension benefits until her deceased husband would have attained the age of 60 years.

Whereas, as per the service record the date of birth of Late Jagat Debbarma, Ex-H/M(Pry) is 11/02/1967 and as per the Notification of the GA(P&T) Department dated 02.03.2019 his wife Smt Mani Debbarma is eligible to get a Special Pension for the period w.e.f 13/06/2024 to 10/02/2027.

Whereas, the last basic pay of Late Jagat Debbarma, Ex-H/M (Pry) was Rs.68400/- and as per PPO No.142449442 dated 09/12/2024 the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E) Tripura @ Rs.34200/-P.M for the period w.e.f 13/06/2024 to 10/02/2034.

Now, therefore, the provisional Special Pension is hereby sanctioned in favour of Smt. Mani Debbarma, W/O Late Jagat Debbarma, Ex-H/M(Pry) at the rate of Rs(68400-34200)=Rs34200/-+ Admissible DR 20% w.e.f 13/06/2024 to 30/06/2024,Rs (68400-34200)=Rs 34200/ + Admissible DR 25% w.e.f 01/07/2024 to 31/10/2024,Rs(68400-34200)=Rs 34200/ + Admissible DR 30% w.e.f 01/11/2024 to 31/03/2025, Rs(68400-34200)=Rs 34200/ + Admissible DR 33% w.e.f 01/04/2025 to time to time increase in admissible DR till 10/02/2027,subject to finalization by the Accountant General (A&E) Tripura and the amount will be debitable under Head of Account 2071-Pension & Other benefits,01-Civil,105-Family Pension 02-Pension,01-General Pension,04-Pensionary Charges(2271-01-105-02-01-04).
