**Sub:** Sanctioning Provisional Special Pension in favour of Smt Manju Debbarma, W/O Late Kajal Debbarma, Ex-UGT of Mandwi Bazar H/S (Pry) School under HO & DDO H/M Mandwi Bazar H/S, School, Jirania, West Tripura.

**Whereas,** Late Kajal Debbarma, Ex-UGT of Mandwi Bazar H/S (Pry) School under HO & DDO H/M Mandwi Bazar H/S, School, Jirania, West Tripura expired on **12/03/2024** while in service, the case comes under the purview of the 'Scheme for Compassionate Appointment/ Benefit of Government employees of Tripura' vide Notification of the GA(P&T) Department No.F.1(1)-GA(P&T)/18, dated 02/03/2019.

**And**

**Whereas,** Late Kajal Debbarma, Ex-UGT expired at the age of 53 years 05 month 02 days and there is no earning member in the family as per the report of the SDM Mohanpur, West Tripura. His wife Smt Manju Debbarma is entitle under **Support Category-1** in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till her deceased husband would have attained 60 years of age.

**And**

**Whereas,** as per the service record the date of birth of Late Kajal Debbarma, Ex-UGT is **10/10/1970** and as per the Notification of the GA(P&T) Department dated 02.03.2019. His wife Smt Manju Debbarma is eligible to get a Special Pension for the period w.e.f 13/03/2024 to 09/10/2030.

**And**

**Whereas,** the last basic pay of Late Kajal Debbarma, Ex-UGT was Rs.49200/- and as per **PPO No.142447557** dated **20/06/2024** the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E) Tripura @ Rs.24600/- P.M for the period w.e.f 13/03/2024 to 12/03/2034.

Now, therefore the provisional special pension has been sanctioned in favour of Smt Manju Debbarma, W/O Late Kajal Debbarma, Ex-UGT Rs(49200-24600)=Rs.24600/- + Admissible DR+20% DA.w.e.f 13/03/2024 to 30/06/2024 & Rs (49200-24600)= Rs.24600/- + Admissible DR+25% DA.w.e.f 01/07/24 to 09/10//2030. Subject to finalization by the Accountant General (A&E) Tripura and the amount will be debitabe under Head of Account 2071-Pension & Other benefits, 01-Civil, 105-Family Pension 02-Pension, 01- General Pension, 04-Pensionary Charges (2271-01-105-02-01-04).
