Whereas, as per the service record the date of birth of Late Santipriya Chakma, Ex-H/M(Pry) is **05/09/1968** and as per the Notification of the GA(P&T) Department dated 02.03.2019 his wife Smt Mayadebi Chakma is eligible to get a Special Pension for the period w.e.f 30/11/2024 to 04/09/2028.

Whereas, the last basic pay of Late Santipriya Chakma, Ex-H/M(Pry) was Rs.64500/- and as per PPO No.142551943 dated 23/05/2025 the enhanced family pension (EFP) has been sanctioned by the Accountant General(A&E) Tripura @ Rs.32250/-P.M for the period w.e.f 30/11/2024 to 29/11/2034.

Now, therefore, the provisional Special Pension is hereby sanctioned in favour of Smt. Mayadebi Chakma W/O,Late Santipriya Chakma,Ex-H/M(Pry),Rs(64500–32250)=Rs.32250/+ Admissible DR 30% w.e.f 30/11/2024 to 31/03/2025 & Rs(64500–32250)=Rs.32250/ + Admissible DR 33% w.e.f 01/04/2025 to time to time increase up to 04/09/2028,subject to finalization by the Accountant General (A&E) Tripura and the amount will be debitable under Head of Account 2071-Pension & Other benefits,01-Civil,105-Family Pension 02-Pension,01-General Pension,04-Pensionary Charges (2271-01-105-02-01-04).
