**Whereas,** Late. Manindra Ch. Debnath, Ex-UGT under HO & DDO, Inspector of Schools, Sonamura, Sepahijala Tripura expired on **24/11/2018** while in service, the case comes under the purview of the 'Scheme for Compassionate Appointment/ Benefit of Government employees of Tripura vide Notification of the GA(P&T) Department No.F.1(1)-GA(P&T)/18, dated 02/03/2019.

**Whereas,** Late. Manindra Ch. Debnath, Ex-UGT expired at the age of 59 years 04 month 25 days and there is no earning member in the family as per the report of the SDM, Sonamura, Sepahijala Tripura. His wife Smt. Namita Debnath, is entitled under **Support Category-1** in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till her deceased husband would have attained 60 years of age.

**Whereas,** as per the service record the date of birth of Late. Manindra Ch. Debnath, Ex-UGT, is **30/06/1959** and as per the Notification of the GA(P&T) Department dated 02.03.2019 his wife Smt. Namita Debnath, is eligible to get a Special Pension for the period w.e.f. 25/11/2018 to 29/06/2019.

**Whereas,** the last basic pay of Late Manindra Ch. Debnath, Ex-UGT, was Rs.21200/- and as per **PPO No.141924129 dated 28/04/2021** the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E) Tripura @ Rs.21200/- P.M for the period w.e.f 25/11/2018 to 24/11/2028.

Now, therefore the provisional special pension has been sanctioned in favour of of Smt.Namita Debnath, W/O.Lt. Manindra Ch. Debnath, Ex-UGT of Rs(42400-21200)=Rs.21200/- the special pension to be granted in favour of the survivors in respect of expired employee w.e.f 25/11/2018 to 29/06/2019 subject to finalization by the Accountant General (A&E) Tripura and the amount will be debitible under Head of Account 2071-Pension & Other benefits,01-Civil,105-Family Pension 02-Pension, 01- General Pension,04-Pensionary Charges (2271-01-105-02-01-04).
