**Whereas,** Lt Sudhanya Debbarma, Ex- UGT of Ramdol Modal High(Pry) School, under HO & DDO Inspector of Schools Jampuijala, Sepahijala, Tripura expired on 20/11/2023 while in service, the case comes under the purview of the 'Scheme for Compassionate Appointment/ Benefit of Government employees of Tripura' vide Notification of the GA(P&T) Department No.F.1(1)-GA(P&T)/18, dated 02/03/2019.

**Whereas,** Lt Sudhanya Debbarma, Ex-UGT expired at the age of 51 years 10 month 17 days and there is no earning member in the family as per the report of the SDM, Jampuijala, Sepahijala, District his wife Smt. Parija Debbarma is entitle under **Support Category-1** in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till her deceased husband would have attained 60 years of age.

**Whereas,** as per the service record the date of birth of Lt Sudhanya Debbarma. Ex- UGT is 03/01/1972 and as per the Notification of the GA(P&T) Department dated 02.03.2019, his wife Smt Parija Debbarma is eligible to get a Special Pension for the period w. e. f. 21/11/2023 to 02/01/2032.

**Whereas,** the last basic pay of Lt Sudhanya Debbarma, Ex- UGT was Rs.47800/- and as per PPO No.142445820 dated 23-02-2024 the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E), Tripura @ Rs.23900/- P.M for the period w. e. f. 21/11/2023 to 20/11/2033.

Now, therefore the provisional special pension has been sanctioned in favour of Smt. Parija Debbarma, W/O.Late Sudhanya Debbarma. Ex- UGT @ Rs (47800-23900)=Rs.23900/- + Admissible DR+ 20% DA w.e.f 21/11/2023 to 31/12/2023 & Rs. (47800-23900)=Rs.23900/-+Admissible DR+25%DA w.e.f.01/01/2024 to 02/01/2032. Subject to finalization by the Account General (A&E) Tripura and the amount will be debit able under Head of Account 2071-Pension & Other benefits, 01-Civil, 105-Family Pension 02-Pension, 01- General Pension,04-Pensionary Charges (2271-01-105-02-01-04).
