Whereas, as per the service record the date of birth of Late Birendra Debnath, Ex-, A/T is 30/12/1967 and as per the Notification of the GA(P&T) Department dated 02.03.2019. His wife Smt Pranita Debnath is eligible to get a Special Pension for the period w.e.f 05/12/2020 to 29/12/2027.

Whereas, the last basic pay of Late Birendra Debnath, Ex-, A/T was Rs.49200/- and as per PPO No.142445200 dated 04/01/2024 the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E)Tripura @ Rs.24600/-P.M for the period w.e.f 05/12/2020 to 04/12/2030.

Now, therefore the provisional special pension has been sanctioned in favour of Pranita Debnath, W/O Late Birendra Debnath, Ex-,A/T of Rs (49200-24600)= Rs.24600 w.e.f 05/12/2020 28/02/2021 & Rs(49200-24600)= Rs.24600/- + Admissible DR 3% .w.e.f 01/03/2021 to 30/06/2022 & Rs(49200-24600)=Rs.24600/- + Admissible DR 8% w.e.f 01/07/2022 to 30/11/2022 & Rs (49200-24600)= Rs.24600/- + Admissible DR 20% w.e.f 01/12/2022 to 30/06/2024 & Rs(49200-24600)= Rs.24600/- + Admissible DR 25% w.e.f 01/07/2024 to 30/10/2024 & Rs(49200-24600) = Rs.24600/- + Admissible DR 30% w.e.f 01/11/2024 to time to time increase upto 29/12/2027.
