Sub: Sanctioning Provisional Special Pension in favour of Smt Pabitra Debbarma W/O Late Ranjit Debbarma Ex- KBT of Watilong Tilla J.B School under HO & DDO Inspector of Schools Kalyanpur, Khowai Tripura.

Whereas, Late Ranjit Debbarma, Ex- KBT of Watilong Tilla J.B School under HO & DDO Inspector of Schools, Kalyanpur, Khowai, Tripura expired on **12/02/2024** while in service, the case comes under the purview of the 'Scheme for Compassionate Appointment/ Benefit of Government employees of Tripura' vide Notification of the GA(P&T) Department No.F.1(1)-GA(P&T)/18, dated 02/03/2019.

And

Whereas, Late Ranjit Debbarma, Ex- KBT expired at the age of 57 years 07 days and there is no earning member in the family at the time of death on **12/02/2024** as per the report of the SDM Teliamura, Khowai Tripura. His wife Smt Pabitra Debbarma is entitled under **Support Category-1** in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till her deceased husband would have attained 60 years of age.

And

Whereas, as per the service record the date of birth of Late Ranjit Debbarma, Ex- KBT is **05/02/1967** and as per the Notification of the GA(P&T) Department dated 02.03.2019 his wife Smt Pabitra Debbarma is eligible to get a Special Pension for the period w.e.f 13/02/2024 to 04/02/2027.

And

Whereas, the last basic pay of Late Ranjit Debbarma, Ex- KBT was Rs.64500/- and as per **PPO No.142550437 dated 27/02/2025** the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E) Tripura @ Rs.32250/-P.M for the period w.e.f 13/02/2024 to 04/02/2034.

Now, therefore the provisional special pension has been sanctioned in favour of Smt Pabitra Debbarma W/O Late Ranjit Debbarma, Ex-KBT of Rs(64500-32250)=Rs.32250/+ Admissible DR 20% w.e.f 13/02/2024 to 30/06/2024. Rs(64500-32250)=Rs.32250/+ Admissible DR 25% w.e.f 01/07/2024 to 31/10/2024. Rs (64500-32250)= Rs.32250/+ Admissible DR 30% w.e.f 01/11/2024 to 31/03/2024 & Rs(64500-32250)=Rs.32250/+ Admissible DR 33% w.e.f 01/04/2025 to time to time increase Admissible DR up to 04/02/2027 subject to finalization by the Accountant General (A&E) Tripura and the amount will be debitale under Head of Account 2071-Pension & Other benefits, 01-Civil, 105-Family Pension 02-Pension, 01- General Pension, 04-Pensionary Charges (2271-01-105-02-01-04).
