**Sub:** Sanctioning Provisional Special Pension in favour of Smt Pushpa Rani Debbarma, W/O Late Subodh Debbarma, Ex-KBT of Sepahijala Banapalli J.B School under HO & DDO Inspector of Schools, Bishalgarh, Sepahijala, Tripura.

**Whereas,** Late Subodh Debbarma, Ex-KBT of Sepahijala Banapalli J.B School under HO & DDO Inspector of Schools, Bishalgarh, Sepahijala, Tripura expired on **13/10/2023** while in service, the case comes under the purview of the 'Scheme for Compassionate Appointment/ Benefit of Government employees of Tripura' vide Notification of the GA(P&T) Department No.F.1(1)-GA(P&T)/18, dated 02/03/2019.

**And**

**Whereas,** Late Subodh Debbarma, Ex-KBT expired at the age of 55 years 09 month 10 days and there is no earning member in the family at the time of death on 13/10/2023 as per the report of the SDM Jampuijala, Sepahijala Tripura. His wife Smt Pushpa Rani Debbarma is entitled under **Support Category-1** in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till her deceased husband would have attained 60 years of age.

**And**

**Whereas,** as per the service record the date of birth of Late Subodh Debbarma, Ex-KBT is **03/01/1968** and as per the Notification of the GA(P&T) Department dated 02.03.2019, his wife Smt Pushpa Rani Debbarma is eligible to get a Special Pension for the period w.e.f 14/10/2023 to 02/01/2028.

**And**

**Whereas,** the last basic pay of Late Subodh Debbarma, Ex-KBT was Rs.62600/- and as per PPO No.142447807 dated **05/06/2024** the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E) Tripura @ Rs.31300/- per month for the period w.e.f 14/10/2023 to 13/10/2033.

Now, therefore the provisional special pension has been sanctioned in favour of Smt Pushpa Rani Debbarma, W/O Late Subodh Debbarma, Ex-KBT at the rate of Rs (62600-31300)= Rs.31300/- + Admissible DR 20% w.e.f 14/10/2023 to 31/12/2024 & Rs (62600-31300)= Rs.31300/- + Admissible DR 25% w.e.f 01/01/24 to 31/10/2024 & Rs (62600-31300)= Rs.31300/- + Admissible DR 30% w.e.f 01/11/2024 subject to finalization by the Accountant General (A&E) Tripura and the amount will be debitible under Head of Account 2071-Pension & Other benefits, 01-Civil, 105-Family Pension 02-Pension, 01- General Pension, 04-Pensionary Charges (2271-01-105-02-01-04).
