Sub:- Sanctioning Provisional Special Pension in favour of Smt.Rimjamkhan Halam, W/O.Late. Raichungjoy Halam,Ex-Group-D of Mechuria S.B School under HO & DDO, Inspector of Schools, Salema, Dhalai Tripura.

Whereas, Late. Raichungjoy Halam,Ex-Group-D under HO & DDO, Inspector of Schools Salema, Dhalai Tripura expired on **16/02/2024** while in service, the case comes under the purview of the 'Scheme for Compassionate Appointment/ Benefit of Government employees of Tripura vide Notification of the GA(P&T) Department No.F.1(1)-GA(P&T)/18, dated 02/03/2019.

And

Whereas, Late. Raichungjoy Halam, Ex-Group-D expired at the age of 53 years 01 month 06 days and there is no earning member in the family as per the report of the SDM, Kamalpur, Dhalai Tripura. His wife Smt. Rimjamkhan Halam, is entitle under **Support Category-1** in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till her deceased husband would have attained 60 years of age.

And

Whereas, as per the service record the date of birth of Late. Raichungjoy Halam, Ex-Group-D, is 10/01/1971 and as per the Notification of the GA(P&T) Department dated 02.03.2019. His wife Smt. Rimjamkhan Halam, is eligible to get a Special Pension for the period w.e.f.17/02/2024 to 09/01/2031.

And

Whereas, the last basic pay of Late Late. Raichungjoy Halam, Ex-Group-D, was Rs.18250/- and as per **PPO No.142448853 dated 01/10/2024** the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E) Tripura @ Rs.18250/- P.M for the period w.e.f 17/02/2024 to 16/02/2034.

Now, therefore the provisional special pension has been sanctioned in favour of Smt. Rimjamkhan Halam, W/O.Late. Raichungjoy Halam, Ex-Group-D of Rs(36500-18250)=Rs.18250/-+ Admissible DR+25%. w.e.f 17/02/2024 to 31/10/2024 & Rs (36500-18250)=Rs.18250/- + Admissible DR+30%. w.e.f 01/11/2024 to 31/03/2025 & Rs.(36500-18250)=Rs.18250/- + Admissible DR +33%. w.e.f 01/04/2025 to 30/09/2025 & Rs(36500-18250)=Rs.18250/-+ Admissible DR+36%. w.e.f 01/10/2025 to time to time increase DA up to 09/01/2031. Subject to finalization by the Account General (A&E) Tripura and the amount will be debitabe under Head of Account 2071-Pension & Other benefits;01-Civil,105-Family Pension 02-Pension, 01- General Pension,04-Pensionary Charges (2271-01-105-02-01-04).
