**Whereas,** Lt Tanilal Debbarma Ex-UGT of Nilpurna Kalai Coloni SB School under HO & DDO Inspector of Schools Dukli West Tripura expired on **16/07/2022** while in service. The case comes under the purview of the 'Scheme for Compassionate Appointment/ Benefit of Government employees of Tripura' vide Notification of the GA(P&T) Department No.F.1(1)-GA(P&T)/18, dated 02/03/2019.

And

**Whereas,** Lt Tanilal Debbarma Ex-UGT expired at the age 53 years 10 month 05 days and there is no earning member in the family as per the report of the SDM, Sadar, West Tripura his wife ~~Smt. Sampa Debbarma~~ is entitle under **Support Category-1(one)** in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till her deceased husband would have attained 60 years of age.

**Whereas,** as per the service record the date of birth of Lt.Tanilal Debbarma Ex- UGT is **11/09/1968** and as per the Notification of the GA(P&T) Department dated 02.03.2019, his wife Smt Sampa Debbarma is eligible to get a Special Pension for the period w.e.f 17/07/2022 to 10/09/2028.

And

**Whereas,** the last basic pay of Lt Tanilal Debbarma Ex- UGT was Rs.44600/- and as per **PPO No.142341591** dated 08-04-2023 the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E), Tripura @ Rs.22300/- P.M for the period w.e.f 17/07/2022 to 16/07/2032.

**Now,** therefore the provisional special pension has been sanctioned in favour of Smt. Sampa Debbarma W/O Late Tanilal Debbarma Ex- UGT @ Rs (44600-22300)=Rs 22300/- + Admissible DR+ 8% DA w.e.f 17/07/2022 to 30/11/2022 & @ Rs (44600-22300)=Rs 22300/- +Admissible DR+ 20% DA w.e.f 01/12/2022 to 10/09/2028 subject to finalization by the Account General (A&E) Tripura and the amount will be debit able under Head of Account 2071-Pension & Other benefits, 01-Civil, 105-Family Pension 02-Pension, 01- General Pension,04-Pensionary Charges (2271-01-105-02-01-04).
